RESOLUTION NO. 09-117

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, ORDERING THE VACATION OF ROAD RIGHT-OF-WAY LOCATED ON A PORTION OF 40TH STREET EAST, NORTH OF AVENUE J AND SOUTH OF LANCASTER BOULEVARD.

WHEREAS, the excess road right-of-way is not required.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LANCASTER, STATE OF CALIFORNIA, THAT:

- Section 4. That the City Council finds, from all the evidence submitted, that the right-of-way as described in its Resolution of Intention, Resolution No. 09-95, is unnecessary for present or prospective road purposes.
- Section 5. The City Council does hereby order the vacation of that certain road right-of-way to the owner of record, as described and shown in Exhibits "A" and "B".






