2. Master Plan for Trails and Bikeways Update

Elma Watson presented an update on the Master Plan for Trails and Bikeways. She stated that Los Angeles County hired a policy analyst, Margaret Hernandez, for the project. The Master Plan for Trails and Bikeways Survey has been posted online and is now available to the public in both English and Spanish; the latest response count from the English version was 111, Spanish version 11. She reported that September 30, 2010, was the first Community Workshop with 40 in attendance. The next workshop, Disabled Stakeholders meeting, has been scheduled for Monday, November 1, 2010, from 2:00 p.m. to 4:00 p.m. at the EOC. She distributed fliers of the Master Plan for Trails and Bikeways to announce the Community Open House on November 13, 2010, from 8:00 a.m. to noon, and LanCoaster Bike Ride/Walk on November 13, 2010, from 9:00 a.m. to 11:00 a.m. She concluded that Dan Burden would be joining Ryan Snyder (consultant) for the Master Plan for Trails and Bikeways project. There will be a walk audit January 28 and 29, 2011, times to be determined; Staff will notify the Commission.

The Commission concurred to discuss Agenda Item No. 4, and acknowledge the speaker Bonnie Stone, before scheduled tour/walk (Agenda Item No. 3).

Bonnie Stone stated, in the previous meeting of September 23, 2010, of her desire for tourism and walking tours of older homes in the Lancaster area, and presented a list of these homes to the Commission. She concluded she would email photos of the homes to Staff.
