

RESOLUTION NO. 11-18

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, COMMITTING THE CITY OF LANCASTER TO PROVIDE LOCAL MATCH FUNDS FOR TWO SUBMITTED BICYCLE TRANSPORTATION ACCOUNT GRANT APPLICATIONS

WHEREAS, the California Bicycle Transportation Account (BTA) provides state funds for city and county projects that improve safety and convenience for bicycle commuters; and

WHEREAS, the State of California, Bicycle Facilities Unit, has the responsibility for the administration of the program within the State, setting up necessary procedures governing project applications under the program; and

WHEREAS, the City submitted two grant applications on March 18, 2011, and proposes to improve the Class II bike lanes on Lancaster Boulevard between 10<sup>th</sup> Street West and Valley Central Way, and between Sierra Highway and Division Street, and install new Class II bike lanes on 20<sup>th</sup> Street West between Avenue J-8 and Avenue L; and

WHEREAS, the two proposed projects are included in the Amended City of Lancaster Bicycle Transportation Plan 2008; and

WHEREAS, the City of Lancaster, if selected, will enter into an agreement with the State of California to complete the project.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LANCASTER, STATE OF CALIFORNIA, THAT:

Section 1. The City of Lancaster certifies that it has, or will have available prior to commencement of any work on the projects included in the application, sufficient funds to operate and maintain the projects.

Section 2. The City of Lancaster approves the use of \$50,000 from a capital improvement fund for the ten percent (10%) grant matching requirement.
