A RESOLUTION OF THE LANCASTER REDEVELOPMENT AGENCY, APPROVING THE PAYMENT OF THE SUPPLEMENTAL EDUCATION REVENUE AUGMENTATION FUND (SERAF) DEPOSIT WITH A LOAN FROM THE LOW AND MODERATE INCOME HOUSING FUND

WHEREAS, the Agency is required to make a deposit in Fiscal Year 2010/11 to the Supplemental Education Revenue Augmentation Fund (SERAF) as required by Health & Safety Code Section 33690; and

WHEREAS, the Agency has insufficient funds with which to make such payment without borrowing a portion of the funds from the Low and Moderate Income Housing Fund as authorized by Health & Safety Code Section 33690.(c).

NOW, THEREFORE, THE LANCASTER REDEVELOPMENT AGENCY DOES HEREBY RESOLVE AND DETERMINE THAT:

Section 1. The Lancaster Redevelopment Agency hereby finds and declares that there are insufficient funds with which to make the payment required by Health & Safety Code Section 33690.(c) without borrowing a portion of such amount from the Low and Moderate Income Housing Fund.

Section 2. The Agency hereby approves and ratifies a loan from the Low and Moderate Income Housing Fund in an amount not to exceed 100% of the amount required to be deposited in such fund for Fiscal Year 2010/11, subject to the prior pledge of such revenues to the payment of debt service on any outstanding bonds of the Agency. Such loan shall be repaid in accordance with State law.
