

RESOLUTION NO. 11-82

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, APPROVING THE APPLICATION FOR THE CITY OF LANCASTER TO ESTABLISH A CERTIFIED BEVERAGE CONTAINER RECYCLING COLLECTION CENTER; AND IF SELECTED, APPROVING THE EXECUTION OF A STANDARD AGREEMENT AND ANY AMENDMENTS THERETO; AND ANY RELATED DOCUMENTS NECESSARY TO PARTICIPATE IN ALL CALRECYCLE BEVERAGE CONTAINER RECYCLING PROGRAMS.

WHEREAS, the California Beverage Container Recycling and Litter Reduction Act authorizes the Department of Resources Recycling and Recovery (CalRecycle), formerly known as the California Integrated Waste Management Board, to oversee the implementation of a Certified Beverage Recycling Collection Center Program to encourage beverage container recycling and promote community based recycling activities statewide.

WHEREAS, procedures established by CalRecycle require each Applicant's governing body to certify by resolution its approval of the submittal of a Certified Beverage Container Recycling Collection Program Application to CalRecycle; and

WHEREAS, if awarded, the City of Lancaster will enter into an agreement with CalRecycle for implementation of said program.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LANCASTER, STATE OF CALIFORNIA, THAT:

Section 1. The City of Lancaster authorizes the submittal of an application to CalRecycle granting the City of Lancaster to establish a Certified Beverage Container Recycling Program.

Section 2. The Director of Public Works is appointed as an agent of the City Council of the City of Lancaster, California, to conduct all negotiations, execute and submit all documents, including, but not limited to: applications, agreements, amendments, payments, and so on, which may be necessary for the completion of the aforementioned project.

Section 3. All costs associated with maintaining and managing a Certified Beverage Container Recycling Program have been approved using existing Beverage Recycling Container grant funds.

Section 4. If the application is approved, the City of Lancaster hereby agrees to use the collection program for eligible activities in the manner presented within the approved application, as approved by the Department of Public Works, and in accordance with the regulations cited above. The City of Lancaster may also execute a standard agreement, any amendments thereto, and any and all other documents or instruments necessary or required by CalRecycle for participation in the Beverage Container Recycling Collection Center Program (collectively, the required documents).

Section 5. This Resolution is consistent with the budgetary and financial circumstances of the City of Lancaster, as of the date hereof. No money from sources other than Grant funds received are, or are reasonably expected to be reserved, allocated on a long-term basis, or otherwise set aside by the City of Lancaster (or any related party), pursuant to their budget or financial policies with respect to the costs of this CalRecycle application. To the best of our knowledge, the City of Lancaster is not aware of the previous adoption of official intents by the City of Lancaster that have been made as a matter of course for the purpose of reimbursing expenditures and for which tax-exempt obligations have not been issued.

Section 6. This Resolution is adopted as an official action of the City of Lancaster, in order to comply with the California Beverage Container Recycling and Litter Reduction Act and any other regulations of CalRecycle relating to the qualification of the City of Lancaster expenditures incurred prior to the date of issue of this application, is part of the City's official proceedings, and will be available for inspection by the general public at the main administrative office of the City of Lancaster.

Section 7. All the recitals in this Resolution are true and correct and the City of Lancaster so finds, determines, and represents.
