

RESOLUTION NO. 12-17

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, APRIL 10, 2012, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Lancaster, California on Tuesday, April 10, 2012, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law, voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California; and

WHEREAS, the City Clerk has canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LANCASTER, STATE OF CALIFORNIA, THAT:

Section 1. The whole number of ballots cast at the precincts except *vote-by-mail* ballots and provisional ballots was **2554**.

The whole number of vote-by-mail ballots cast in the City was **6117**; the whole number of provisional ballots cast in the City was **433**, making a total of **9104** ballots cast in the City.

The total percentage of voter turnout was **14.5%**.

Section 2. The names of the persons nominated and voted for at the election for Mayor and City Council are as follows:

Section 3. The number of votes given at each precinct and the number of votes given in the City to each of the persons nominated are listed on the official tally sheet attached as "Exhibit A".

Section 5. The City Council does hereby declare and determines that:

- R. Rex Parris was re-elected as Mayor for the full term of four years;
- Sandra Johnson was elected as a Member of the City Council for a full term of four years;
- Ken Mann was re-elected as a Member of the City Council for a full term of four years;

Section 6. The City Clerk shall enter in the records of the City Council of the City of Lancaster, a statement of the results of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) The office each person was voted for; (4) The number of votes given at each precinct to each person; (5) The **total** number of votes given to each person.

Section 7. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; the City Clerk shall also administer to each person elected, the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 9. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
