

RESOLUTION NO. 12-18

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, COMMITTING THE CITY OF LANCASTER TO PROVIDE LOCAL MATCH FUNDS FOR THREE BICYCLE TRANSPORTATION ACCOUNT GRANT APPLICATIONS

WHEREAS, the California Bicycle Transportation Account (BTA) provides state funds for city and county projects that improve safety and convenience for bicycle commuters; and

WHEREAS, the State of California, Bicycle Facilities Unit, has the responsibility for the administration of this grant program within the State, establishing necessary procedures governing project applications under the program; and

WHEREAS, the City will submit three grant applications on April 27, 2012, and proposes to improve the Class I bike path and Class II bike lanes on Avenue K-8 between 15th Street West and Sierra Highway, install new Class II bike lanes on 12th Street West between Avenue J-8 and Avenue K-8, and to modify traffic signing and striping to add or widen bike lanes on Avenue I from 10th Street West to Challenger Way and on Division Street from Avenue I to Avenue K-4; and

WHEREAS, the three proposed projects are included in the Master Plan of Trails and Bikeways; and

WHEREAS, the City of Lancaster, if selected, will enter into an agreement with the State of California to complete the project.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LANCASTER, STATE OF CALIFORNIA, THAT:

Section 1. The City of Lancaster certifies that it has, or will have available prior to commencement of any work on the projects included in the application, sufficient funds to operate and maintain the projects.

Section 2. The City of Lancaster approves the use of approximately \$300,000.00 from a capital improvement fund for the ten percent (10%) grant matching requirement.
