

RESOLUTION NO. 12-67

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, AMENDING RESOLUTION NUMBER 05-233 BY ADDING FACILITY RENTAL FEES FOR AMERICAN HEROES PARK AND REVISING RENTAL FEES FOR THE MUSEUM OF ART AND HISTORY (MOAH)

WHEREAS, under the approval of the City Council, basic rates concerning use of City facilities are established by resolution; and

WHEREAS, American Heroes Park is a park facility located at 701 W. Kettering Street, Lancaster, CA 93534, for which rental fees have not yet been established; and

WHEREAS, the rental fees for the Museum of Art and History need to be revised.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LANCASTER DOES HEREBY RESOLVE, DETERMINE AND FIND AS FOLLOWS:

Section 1. The schedule of fees for American Heroes Park set forth below is hereby approved.
