Status report on draft landlord liability ordinance

Chairman Derryberry gave an update regarding the landlord liability ordinance. The ordinance was presented to representatives of Greater Antelope Valley Association of Realtors (GAVAR). GAVAR expressed a concern with the imposing fines and stated the landlords can't resolve the problem if the landlord is unaware of a problem. The City will work on a new policy which would send out notification to the landlord of a dog bite occurring on their property. This would put the landlord on notice of potential vicious dog on property allowing them to rectify the situation.

Chairman Derryberry thanked the commission for their work on the landlord liability ordinance.

Brenda Gamlowski stated the Mariposa area has been selected as the neighborhood that the City will be working on for this year's revitalization project. The City should be working on beautifying the area to help with the real estate market. Maybe the City should think about Benefit Assessment Districts to assist neighborhoods with broken fences and other maintenance needs. It may bring jobs to the area. He feels there are three major eye sore areas in Lancaster; 20<sup>th</sup> Street West from Lancaster Boulevard to Avenue J-12 which runs along the freeway; Avenue K and 3<sup>rd</sup> Street East; and Avenue J and Kingtree Avenue.
