**JNB 101 TRANSFER OF FUNDS FROM CITY OF LANCASTER TO LANCASTER

The Finance Director presented the staff report regarding this matter.

Pursuant to Health and Safety Code (HSC) Section 34179.6(c), the City of Lancaster Successor Agency (Agency) completed an Other Funds and Accounts Due Diligence Review (Review) and submitted it to the Oversight Board and subsequently to Department of Finance (DOF) for review.

The DOF completed its review and issued a determination letter on March 8, 2013 concluding that it disallowed a loan repayment transfer from the Agency to the City of Lancaster in the amount of \$118,244. The Agency is required to remit the funds within five working days or be subject to penalties including the possibility of withholding of sales and property tax funds.

**NB 2. AMENDMENT TO CHAPTER 9.44 OF THE LANCASTER MUNICIPAL CODE RELATING TO REGISTERED SEX OFFENDERS**

The Deputy City Attorney presented the staff report regarding this matter.

Addressing the City Council on this matter:

Andrew Nieto – agrees with the ordinance; stated his concerns regarding the limits placed on offenders regarding Halloween; unconstitutional and should be handled at the State level; needs to be equal protection.

Council Member Smith clarified that the State took care of this with legislation; it is considered a pre-emption and gives cities the authority to set additional standards.

Robert Long – supports the ordinance; discussed the permanent damage that is done to a child who is molested; in favor of the Halloween restrictions.

Vice Mayor Crist stated that it is the intention of the City Council to give law enforcement every tool possible to protect the citizens of this City.

**CA 2. DISCUSSION AND POSSIBLE ACTION REGARDING PROPOSED FUNDING FOR IMPROVEMENTS AT LANCASTER METROLINK STATION**

Vice Mayor Crist stated that he and Mayor Parris have been researching this issue for some time and believe the best way to serve the community's transportation needs is to work hand-in-hand with the City of Palmdale. Currently, there are two Metrolink stations and rather than maintaining the status quo in which Metrolink is forced to divide funding between the two cities, it would be in the region's best interest to devote the funding to a single transportation center. The Palmdale Transportation Center is the ideal location for this all-purpose transit hub. Both cities have been working with the California High-Speed Rail authority to determine the best route for the proposed train in order to minimize any negative impact and maximize usability for the residents. The resources and staff time of both cities, as well as those of MTA would be best used to establish one first-rate transportation center. Both cities have a vision for this community and believe the citizens will be best served by one transportation hub.

It was the consensus of the City Council to direct the City Manager to set up a meeting with the officials of the City of Palmdale to discuss this matter and move forward.

The Board approved warrants in the amount of \$287,406.78. The warrants issued by the District are for costs incurred for operation and maintenance, such as electricity, water, telephone, and chemicals, and for relatively small capital projects; approved a departmental invoice in the amount of \$2,213,281.81. The invoice is an internal document that transfers each District's proportionate share of expenditures made by District No. 2, the administrative District, on behalf of the participating Districts; authorized advertising and receipt of bids for a 3-Ton Bridge Crane at Palmdale Water Reclamation Plant (WRP); approved and ordered executed an agreement with Terra Renewal for loading, removal, transportation and reuse of biosolids generated at the Lancaster WRP. 
