

RESOLUTION NO. 13-11

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, DIRECTING AND AUTHORIZING THE STREET NAME CHANGE OF 7TH STREET WEST TO BYD BOULEVARD BETWEEN AVENUE H AND AVENUE G AND THE STREET NAME CHANGE OF AVENUE G-12 TO DREAM WAY BETWEEN SIERRA HIGHWAY AND 7TH STREET WEST

WHEREAS, the City of Lancaster (hereinafter referred to as the “City”) is a charter city and municipal corporation duly organized and existing pursuant to and under the provisions of the laws of the State of California; and

WHEREAS, the City Council, by its statute authority, has previously approved the street name for 7th Street West and Avenue G-12; and

WHEREAS, the City Council from time to time may determine that naming certain physical features of the City of Lancaster after individuals, events, or businesses will provide a source of pride and community recognition; and

WHEREAS, BYD Boulevard and Dream Way are not in conflict with the public interests and welfare; and

WHEREAS, the change of such street names are warranted.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LANCASTER, STATE OF CALIFORNIA, THAT:

Section 1. The portion of 7th Street West between Avenue H and Avenue G shall be renamed “BYD Boulevard”.

Section 2. The portion of Avenue G-12 between Sierra Highway and 7th Street West shall be renamed “Dream Way”.

Section 3. The Public Works Department is hereby directed to change existing street name signs as affected by this Resolution.

Section 4. The City Clerk is hereby ordered to cause a certified copy of this Resolution, attested to by the City Clerk under the seal of the City, to be recorded in the Office of the County Recorder of Los Angeles County and to the Los Angeles County Board of Supervisors.

Section 5. The City Clerk is hereby directed to cause a certified copy of this Resolution, attested to by the City Clerk under seal of the City, to be mailed to the following agencies:
