PRESENTATIONS

 Daddy's Day Care Waki Jones

Mr. Jones gave a presentation on his program, Daddy Day Care. He stated that he has two separate programs: one is child care at his home and the other is an after school program encouraging children to participate in other activities such as: mixed martial arts and dance classes. He would like to expand his programs with additional participants. He is working with the Child Care Resource Center in hopes of getting approval for exempt status. Kelvin Tainatongo, Assistant to the City Manager will check on program status.

2. H.E.L.P.E.R. Foundation Commissioner Muhammad

Commissioner Muhammad gave a presentation on the H.E.L.P.E.R. Foundation. It was established in 1999 and the main focus of the foundation is to help at-risk youth. The goal is to work with law enforcement to provide gang intervention and crime prevention to these youths. The foundation is expanding services to the Antelope Valley Community. The plan is to open a residential facility to assist with at-risk females and give them the tools to sustain and become productive in society.

3. Asthmapolis Patti Garibay

Patti Garibay gave an update on Asthmapolis. Staff met with representatives from local medical providers on May 15, 2013. The input from the medical profession was valuable and the medical community is enthusiastic about the program. Ms. Garibay stated the Commission will be hosting a meeting on the subject at their next month scheduled for Tuesday, July 2, 2013. The meeting will help to determine how to get the program started in Lancaster.
