## **RESOLUTION NO. 13-54**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, DECLARING THAT PORTION OF AVENUE J-11 BETWEEN DIVISION STREET AND YUCCA AVENUE BE CO-NAMED BYD ENERGY ROAD

WHEREAS, the City of Lancaster (hereinafter referred to as the "City") is a charter city and municipal corporation duly organized and existing pursuant to and under the provisions of the laws of the State of California; and

WHEREAS, the City Council, by its statute authority, has previously approved the street name for Avenue J-11; and

WHEREAS, the City Council from time to time may determine that naming certain physical features of the City of Lancaster after individuals, events, or businesses will provide a source of pride and community recognition; and

WHEREAS, BYD Energy Road is not in conflict with the public interests and welfare; and

WHEREAS, the change of such street name is warranted.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LANCASTER, AS FOLLOWS:

- Section 1. The portion of Avenue J-11 between Division Street and Yucca Avenue shall be co-named "BYD Energy Road".
- Section 2. The Public Works Department is hereby directed to change existing street name signs as affected by this Resolution.
- Section 3. The City Clerk is hereby ordered to cause a certified copy of this Resolution, attested to by the City Clerk under the seal of the City, to be recorded in the Office of the County Recorder of Los Angeles County and to the Los Angeles County Board of Supervisors.
