# NB 6. RESOLUTION NO. OB 04-12 - TRANSFER OF HOUSING RESPONSIBILITIES AND ALL RIGHTS, POWERS, DUTIES AND OBLIGATIONS, INCLUDING HOUSING PROPERTIES AND ASSETS TO THE LANCASTER HOUSING AUTHORITY AS PREVIOUSLY APPROVED BY THE LANCASTER CITY COUNCIL ON JANUARY 24, 2012

Legal Counsel explained that properties formerly held by the Agency have been deleteriously affected by a national and regional real estate recession, which has had particularly negative effects within the Antelope Valley. Given current market conditions, it is in the interest of taxing agencies, including those represented on the Lancaster Successor Agency Oversight Board, that properties be marketed in a judicious and careful fashion and not precipitously or in a hurried or random fashion.

The Finance Director stated that on the original draft they had listed the loans from the Agency to the City that are recognized obligation payments. The Department of Finance contacted the City and directed the City to remove this from the schedule because it was excluded as enforceable obligations. Therefore the City has removed this item and has listed it as a footnote to keep track of it.

#### EXECUTIVE DIRECTOR ANNOUNCEMENTS

The Executive Director thanked the people on the Board for accepting these positions and serving in the capacity as the Lancaster Oversight Board. He stated that it is important to note that this is a non-compensated position. Additionally, one of the hardest and worst parts of the legislation that dissolved Redevelopment Agencies is that it pitted organizations against each other, or tried to and in Lancaster this will be handled differently. It is not different taxing entities, which is such a sterile term; but it is the people that work together. While the Community College District might be a taxing entity, it is Antelope Valley College; it is part of the City and always has been; as is the High School District, as is the City of Lancaster. In Lancaster it is the hope that everyone will work together, with the County, with the Fire District, with the Education Community, with the Housing Community. This is a partnership and it will be implemented in the best way, better than anywhere in the State.
