### **EXECUTIVE DIRECTOR ANNOUNCEMENTS**

The Executive Director stated that it helps him to view all of this as a rigged game. It is not fair and the people running the game have a vested interest in cities losing. What the City of Lancaster has tried to do is be smarter; follow the law; use to the advantage of the City; there can be a win and the City is blessed with some very smart people.
