**1. UNITE Update
Patti Garibay**

Patti Garibay gave an update on the UNITE Program. The following seven projects have been selected for the program:

- Literacy Festival at Mariposa Elementary
- Art Project and Community BBQ at Mariposa Park
- Health Fair for HS Students at AV High
- School Community BBQ and activities for families at Lincoln Elementary
- Playground Improvement Projects at Desert View Elementary
- Chess Workshop and Tournament at Mariposa Elementary
- Work Readiness Program at AVPH

UNITE Day is Saturday, September 21st and thank you to the community partners, the City's Safer, Stronger Neighborhoods Committee and to this commission. Hope to see you there.

Chair Derryberry asked if additional sponsorship was needed and Ms Garibay stated that they have sufficient funds for the program at this time. Commission thanked her and the Safer, Stronger Neighborhoods Committee for their efforts.

**2. Americorps Vista Members
Kelvin Tainatongo and Luis Garibay**

Luis Garibay introduced volunteers from Americorps Vista working at City Hall to build a volunteer database for Lancaster. The City of Lancaster has partnered with VISTA (Volunteers In Service To America) to create a volunteer base through non-profit organizations within the community. They will be working on a survey and sending it out in the next month and will begin research. Their goal is to encourage citizens to volunteer for the various organizations and promote community empowerment and engagement.

**3. Tapestry Commission
Brenda Gamlowski**

Brenda Gamlowski gave a presentation on the Tapestry Commission. They are beginning it's "Bridge to Empowerment Season ". With a new theme each month through the end of the year, the goal of the season is to highlight local organizations, community activities, and resources which will bring community awareness to each specific monthly topic. In September, Tapestry will kick off the season by celebrating Cultural Diversity. The theme of Self-Esteem & Personal Security will be highlighted in October. November's theme is that of Gratitude, followed by Faith & Celebration in December.

4. Asthamapolis Update
Chair Derryberry

Chair Derryberry gave an update on the Asthamapolis Program. The commission has participated in several workshops with representatives from the medical community. At the meeting held on July 2, 2013, there was discussion on whether the community would benefit from the Asthamapolis device and program. The representative from Asthamapolis was unable to give complete and accurate study results which made it difficult to recommend spending funds on the program. Many felt that it would be best to serve the community through education. It was recommended to partner with the medical professionals and provide education through the Wellness Homes. Chair Derryberry stated the commission has now been put to task to work on this project. He asked that within the next few months we bring back various local organizations to work on a need assessment survey and find out what is needed.
