Background:

The Cedar Avenue Complex is located at the following addresses: 44845 Cedar Avenue known as the Sheriff Substation, 44851 Cedar Avenue known as the Cedar Performing Arts Auditorium and Art Studios, 44857 Cedar Avenue known as the Cedar Art Gallery and 606 West Lancaster Boulevard known as the Dentist Offices.

From the 1930's through the late 1950's, five buildings on the southwest corner of Lancaster Boulevard and Cedar Avenue formed the civil and social center of the Antelope Valley. Lancaster's County Center contained the Valley sheriff's office, health center; county clerk's office, water and building office, assessor's office, justice court and library. The center's Memorial Hall was the Valley's main meeting place, where banquets, dances and concerts were held.

In December 1937, the library and courthouse building were destroyed by fire. The Los Angeles County chief architect designed several new buildings and retained the art-deco style that was popular in the 1920s and especially common for commercial and public buildings.

In 1962, the court and sheriff's station moved out of the Cedar Avenue complex. A veteran's mental health center and the county health department continued using the Cedar Avenue buildings until the late 1980's and the Memorial Hall held performances by the Cedar Street Theater community theater group until the completion of the Lancaster Performing Arts Center in 1991.

The Lancaster Redevelopment Agency acquired the Cedar Avenue Complex form Los Angeles County in 1985 and in 1994 sold it to the Antelope Valley Allied Arts Association. The buildings were used for theater art performances, ballet classes, art studios, art gallery for art exhibitions, and other uses in the field of art. In 2012, the City of Lancaster became the owner of the Cedar Avenue Complex.

After many years and uses, the Cedar Avenue Complex will be renovated to retain and preserve its original character with attention paid to changes that have occurred to the buildings since the 1930's. The City conducted a bid opening for the subject bids on October 14, 2013, at 11:00 a.m., sealed bid envelopes were received, opened, and read aloud for the restoration of the Cedar Avenue Complex.
