NEW PUBLIC HEARINGS

2. CONDITIONAL USE PERMIT NO. 10-22

Chairman Vose opened the public hearing at 6:06 p.m. to hear a request by Portal Ridge Solar, LLC, to construct a 38 megawatt (MW) photovoltaic solar generating facility comprised of two 19 MW solar fields in the Rural Residential 2.5 (RR-2.5) Zone, located 180± acres bounded by Avenue H, Avenue H-8, 80th Street West, and 90th Street West.

The reading of the staff report was waived since an uncontested hearing letter was received from the applicant stating agreement to the findings contained in the staff report and revised conditions list. There were none in the audience who wished to speak in opposition to the request. Public hearing closed at 6:07 p.m.

It was moved by Vice Chairman Hall and seconded by Commissioner Terracciano to grant a one-year extension to February 11, 2015, based on the findings contained in the staff report and subject to the Revised Conditions List, Attachment to Resolution No. 10-50. Motion carried with the following vote (5-0-0-2):

3. <u>DISCUSSION AND DIRECTION ON TEMPORARY BANNER REGULATIONS</u>

Brian Ludicke stated there is room for improvement in the City's code for signs or banners in several areas: clarity of temporary signs; types of material banners; times of use for banners (dates); and how signs should be displayed.

Chairman Vose inquired if the Special Meeting in March would have a presentation of visual signs/banners. Brian Ludicke responded that he would check the City's archives for examples, and will contact Code Enforcement for photos. Chairman Vose inquired if municipal signs are subject to the same codes. Brian Ludicke stated the Code does not specify by name; there is an exemption in the Code for official notices.
