- Section 1. The portion of Sancroft Avenue between Avenue H-11 and Avenue H-14 shall be co-named Burgess Way.
- Section 2. The Development Services Department is hereby directed to change existing street name signs as affected by this resolution.
- Section 3. The City Clerk is hereby ordered to cause a certified copy of this resolution, attested to by the City Clerk under the seal of the City, to be recorded in the Office of the County Recorder of Los Angeles County and to the Los Angeles County Board of Supervisors.
