COMMISSION/ STAFF UPDATES

1. CRIME STATISTICS UPDATE

The Senior Criminal Justice Analyst provided crime and arrest statistics for May 4, 2014 through May 31, 2014 and provided the weekly crime event average and median for May, 2014 and June, 2014. The Senior Criminal Justice Analyst provided total Part 1 Crime Counts by month which compared 2013 and 2014 and provided information for the most active reporting districts for part-one crimes for May 4, 2014 through May 31, 2014. Statistics for Residential Burglary and Larcenies involving vehicles for the most active reporting districts were discussed. Crime trend information for specific part-one crimes for a 52 week time period was given. A spatial trend analysis comparing April 2014 to May 2014 was discussed. The Senior Criminal Justice Analyst provided a list of the repeat calls for service with 10 or more calls for the period of May 4, 2014 through May 31, 2014 and discussed a part-one crime forecast for June.

2. ARREST STATISTICS

Los Angeles County Sheriff Deputy Lopez provided statistics comparing April and May 2014 for the Burglary Suppression team, the LAN-CAP Team and the NARCO Team. Deputy Lopez stated the North County Regional Training Facility in Wrightwood has been renamed after Training Officer Les White, a member of the Search and Rescue Team who served 42 years with the Los Angeles County Sheriff Department. Additionally, Deputy Lopez stated Deputy Jeremy Esswein has been named Lancaster Sheriff Station Deputy of the Year and Deputy Lance Jordan was awarded the Stephen Sorenson award; this award is given to the individual who best exhibits the work ethic and characteristics similar to fallen hero Stephen Sorenson.

3. CALIFORNIA HIGHWAY PATROL UPDATE

California Highway Patrol Lieutenant Broneer provided statistics comparing January through June 2013 to January through June 2014 for DUI arrests, seat belt citations, child restraint citations, total arrests, enforcement contacts, injury collisions, reportable accidents, preventable damage collisions and fatal collisions.

Officer Michael Burton discussed the hiring taking place with the California Highway Patrol and discussed the opportunities available with the CHP such as the SWAT team, K-9, bicycle and equestrian patrol. Officer Burton discussed an upcoming information seminar being held at the University of Antelope Valley. Additionally, the CHP plans to attend local events to provide information to the public.

Discussion among the Commission and staff included the number of positions being filled; Officer Burden stated information regarding hiring can be found on Facebook and on the agency's website.

4. DISTRICT ATTORNEY UPDATE

Deputy District Attorney Steven Frankland from the Los Angeles County District Attorney's Office discussed statistics for the number of felony cases filed in the Antelope Valley for May and compared the number of cases filed in the Antelope Valley to the surrounding areas; additionally Mr. Frankland provided statistics for the number of misdemeanor cases filed. Mr. Frankland complimented the CHP for the Every 15 Minutes Program and stated the District Attorney's office trains with the CHP; the office takes DUI events seriously.

5. BUSINESS WATCH SUBCOMMITTEE/ PUBLIC SAFETY UPDATE

Community Service Officer Tracy Stewart stated the Public Safety Office continues to expand the Business Improvement Group Program and the Neighborhood Watch Program at this time.
