COMMISSION/ STAFF UPDATES

1. CRIME STATISTICS UPDATE

The Senior Criminal Justice Analyst provided crime and arrest statistics for June 1, 2014 through June 28, 2014 and provided the weekly crime event average and median for June, 2014 and July, 2014. The Senior Criminal Justice Analyst provided total Part 1 Crime Counts by month which compared 2013 and 2014 and provided information for the most active reporting districts for part-one crimes for June 1, 2014 through June 28, 2014. Statistics for Residential Burglary and Larcenies involving vehicles for the most active reporting districts were discussed. Crime trend information for specific part-one crimes for a 52 week time period was given. A spatial trend analysis comparing June 2014 to May 2014 was discussed. The Senior Criminal Justice Analyst provided a list of the repeat calls for service with 10 or more calls for the period of June 1, 2014 through June 28, 2014 and discussed a part-one crime forecast for July.

Discussion among the Commission and staff centered on the absence of the group home from the top 10 calls for Service report; this can be attributed to changes made at the group home.

2. ARREST STATISTICS

Los Angeles County Sheriff Deputy Ruiz provided statistics comparing May and June 2014 for the Burglary Suppression team, the LAN-CAP Team and the NARCO Team. Deputy Ruiz discussed upcoming fundraising events for the Sheriff Booster Club including the Fallen Hero's softball game being held at the Lancaster Jethawks Stadium July 13th, a Golf tournament on July 18th and the Booster Club's main fundraiser on October 6th.

3. CALIFORNIA HIGHWAY PATROL UPDATE

California Highway Patrol Lieutenant Broneer provided statistics that compared 2013 to the year to date for over-all arrests, verbal warnings, enforcement contacts, DUI arrests, child restraint and seat belt violations. Additionally Lt. Broneer provided statistics for collisions, reportable accidents, injury accidents and fatal accidents.

Lieutenant Broneer stated he attended the MADD awards in May; Lt. Broneer also discussed the national increase in drunk driving and 'drugged driving' related to the use of narcotics and legalized marijuana in some states as well as the increase in the abuse of prescription medicine. 100% of the officers from the local CHP station were recently trained in the 16-hour Advanced Roadside Impairment Detection and Evaluation course; the training was held in conjunction with Los Angeles County Sheriff Deputies from Lancaster and Palmdale. This training can assist officers in being aware of impaired drivers which may not be as readily recognized as drunk drivers.

The Commission commended the CHP and the Los Angeles County Sheriff Department for collaborating in training officers in the area.

5. BUSINESS WATCH SUBCOMMITTEE/ PUBLIC SAFETY UPDATE

The Public Safety Director stated there are four active Business Improvements Groups (BIG) which continue to meet with additional recruitment occurring for participation in these groups; these business centers are located in the most active crime areas in the city. The BIG groups are having a significant impact on the eastside of town with an emphasis placed in these areas. Chronic nuisance issues are being analyzed by the Public Safety Office and feedback is being gathered from affected businesses/residences (including mobile home parks). The Public Safety Director discussed the recent July 4th event which involved different organizations who worked collaboratively; the event resulted in only 2 minor issues. National Night Out is being held August 7th and is being held in conjunction with the Farmers Market downtown.
