PUBLIC BUSINESS FROM THE FLOOR - NON-AGENDIZED ITEMS

Addressing the City Council at this time:

Don Sepulveda – Executive Officer of Regional Rail for LA Metro, discussed the Metrolink Station and working with the City of Lancaster with the issues at the Metrolink station.

Discussion among Mr. Sepulveda and the City Council included the purpose of the Metrolink, checking tickets as riders board the Metrolink at Union Station and the time frame involved with the issues the City has faced regarding the Metrolink station.

Fran Sereseres – stated she attended a recent Board of Supervisors meeting via videoconference at the Lancaster Library and made them aware of the City's issues with homeless funding and the issue with the Metrolink station.

Jeff Lustgarten – Director of Public Affairs with Metrolink, stated he is aware of the issues at the Metrolink station, looking forward to engaging in dialogue with the City, discussed ridership, and discussed the personnel involved with checking fares on the trains.

Discussion among Mr. Lustgarten and the City Council included of the number of citations and arrests related to riders not having tickets to ride the Metrolink. Mayor Parris discussed holding a meeting with LA Metro, Metrolink and a group of people including staff to create a plan ensuring all riders have a ticket when they arrive in Lancaster.

T. J. Hayes – thanked the Council for standing up for the citizens of Lancaster, stated he is a business owner on Lancaster Blvd who felt welcomed when he opened his business and thanked the Council for creating a welcoming atmosphere.

Wally Melendez – discussed a shopping center in Lancaster and discussed creating a consortium to purchase it.

Kurt Boyer – discussed a nonprofit medical clinic he works with, discussed being recognized by the City regarding the work the nonprofit is involved in.

Sue Plunkett – discussed moving the Metrolink station and the issues related to the homeless in the City.

David Paul – stated the City is a 'problem solver' and discussed Attention Deficit Disorder, thanked the City for the BooLVD event, and discussed the announcement regarding stem cell research occurring in the City.

Michael Rives – discussed property tax statements, specifically he discussed property values related to Sanitation fees.

Council Member Mann provided clarification for Mr. Rives and the fees on his property tax bill. Council Member Mann provided information related to an issue which was put to the voters approximately 10 years ago which built a Sanitation District facility; most recent increase is the last to be used to offset the cost of the bonds which were voted on; the Board of Directors for the Sanitation District is hopeful the bonds may be remortgaged which may result in a savings which may be passed on to taxpayers.
