NB 2. FORM OF POWER PURCHASE AGREEMENTS TO SUPPORT SERVICE COMMENCEMENT FOR LANCASTER CHOICE ENERGY

The City Manager introduced the Deputy City Manager and the Finance Director and acknowledged the work they have put into this project and commended them for the outstanding work done regarding Lancaster Choice Energy.

The Deputy City Manager and the Finance Director presented the staff report on this item.

Council Member Johnson stated she is excited about this program which is a great opportunity to showcase the City's willingness to think outside the box.

Council Member Mann discussed the benefits the citizens will receive as they choose to become a part of Lancaster Choice Energy and discussed the savings customers will receive.

Vice Mayor Crist requested clarification regarding the impact Lancaster Choice Energy will have on the local economy and the timeline for the process as it relates to customers choosing to opt out from the program.

Discussion among the City Council and staff included the possible use of Community Choice Aggregation for water and the process involved. Discussion took place regarding the option for citizens to opt in to the program prior to October if they desire.

Wally Melendez – discussed riders of public buses and the condition of the buses; requested the City consider passing an Ordinance relating to 'soiling' city buses; stated it is very difficult to read the ticket machine at the Metrolink Station.

Terry Fairfield – stated she is the manager of Lancaster Estates Mobile Home Park and discussed vehicles speeding and running stop signs in the park; requested the City consider passing an ordinance allowing tickets to be issued by Los Angeles County Deputies.

Discussion took place regarding the feasibility of putting such an ordinance in place; the mobile home park is private property and has not been speed surveyed which indicates it is not subject to vehicle code enforcement; staff will look into the matter.

Kimberly Clarkson – resides in Lancaster Estates Mobile Home Park and stated these residents pay taxes and suggested city staff visit other mobile home parks to fix these issues that are also present at many mobile home parks in the City.

Wayne Wilson - resides in Lancaster Estates and fears a child will get hurt if the issue isn't resolved.

Vee Friss – discussed the bus service and stated the bus company is not maintaining the ramps; rusty and torn rubber, stated she was injured as a result of the non-maintenance of the buses; discussed the cost to seniors to use the bus.

Vice Mayor Crist discussed rate structure options being discussed by AVTA, and stated the City of Lancaster is against charging seniors to ride the bus.

Darlene Peterson – stated she supports the residents of the Lancaster Estate Mobile Home Park and thanked the City for their work in keeping the Metrolink Station open.
