PH 1. LANCASTER CHOICE ENERGY

Mayor Parris opened the Public Hearing.

The City Manager, Deputy City Manager and the Finance Director presented the staff report on this item. Additionally Brian Goldstein, representing Pacific Energy Advisors, Inc., gave a presentation regarding the rate setting process.

Discussion among staff and the City Council included discussion of the 'exit fee', reduction of rates, and the partnership with Southern California Edison. Additionally the Deputy City Manager clarified that 19,000 households will see a savings of 15%. Discussion of the products being offered by Lancaster Choice Energy including the 100% renewable energy product and discussion of SCE's proposed rate increase took place.

Vice Mayor Crist stated AVTA is recruiting for the positions of Executive Director and Board Counsel and stated the board once again voted, with unanimous results, regarding transitioning to electric buses. Vice Mayor Crist discussed grants for articulating buses, and stated the Board will be looking at the number of riders who ride buses for free and stated FTA funding has been reduced.
