



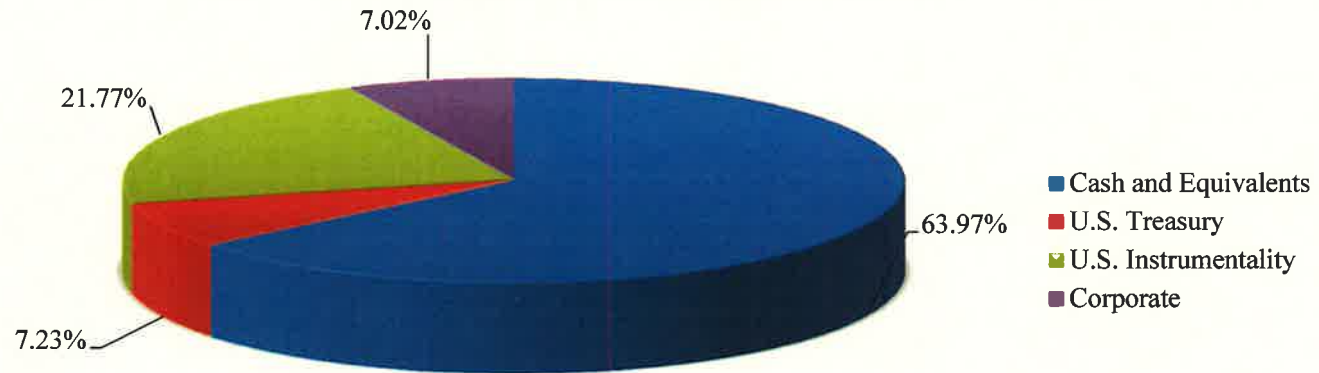

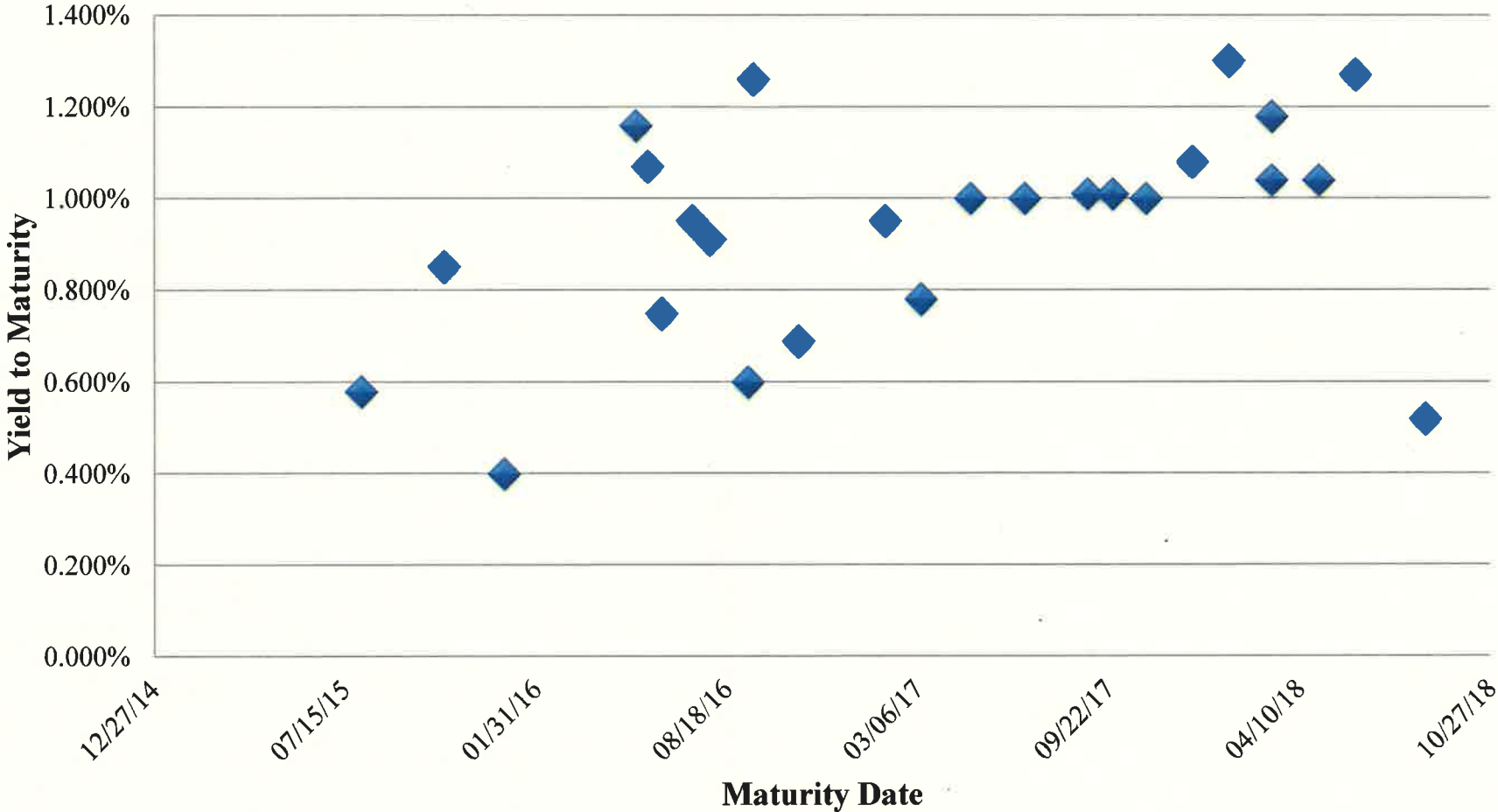

Portfolio / Segment Diversification



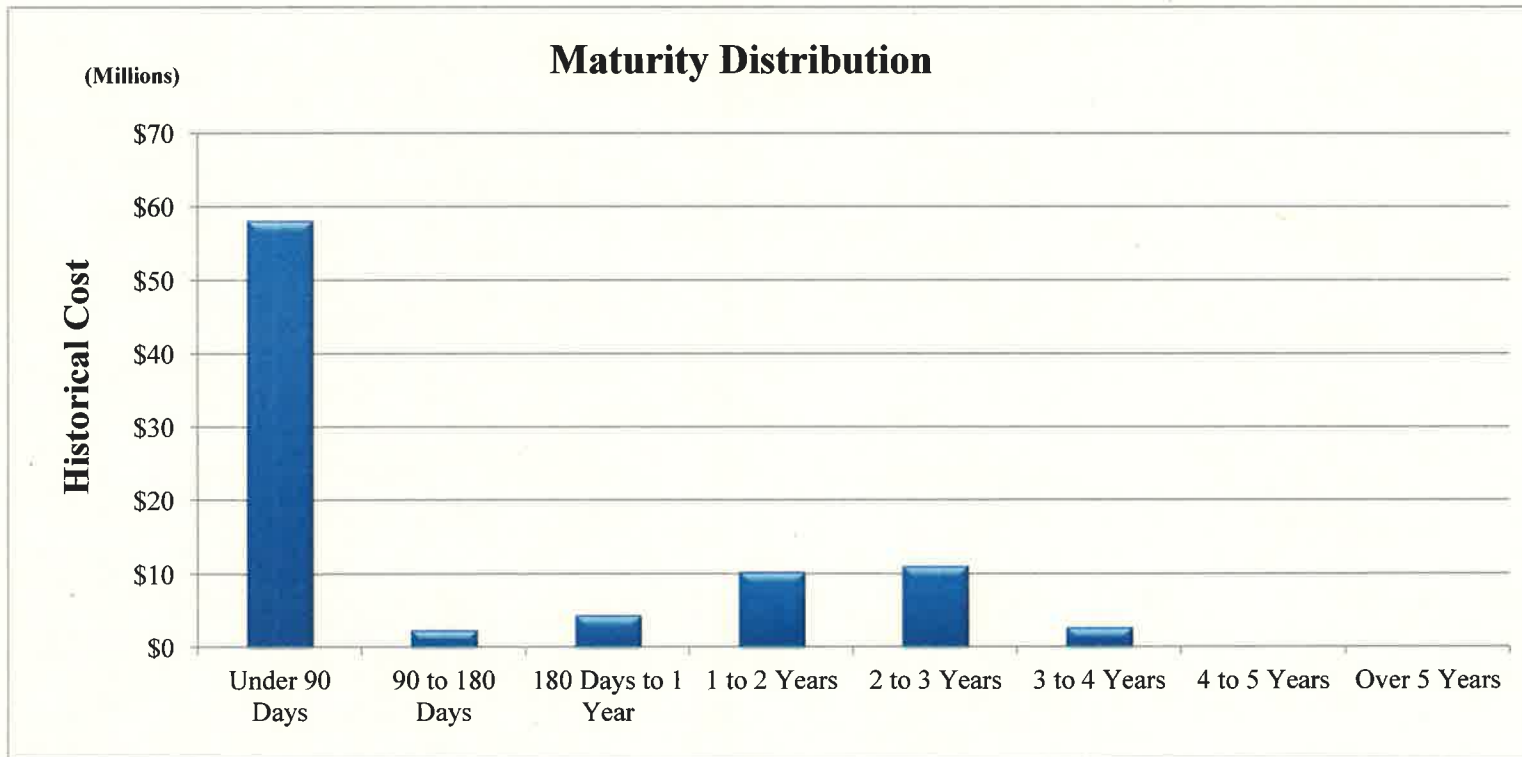
