NB 1. PARTNERSHIP WITH THE CORPORATION FOR NATIONAL AND COMMUNITY SERVICE TO HOST AMERICORP VOLUNTEERS IN SERVICE TO AMERICA (VISTA) MEMBERS

The City Manager and the Lancaster Neighborhood Vitalization Commission Chairman presented the staff report regarding this matter. The AmeriCorp VISTA's presented an End of the Year Progress Report for the projects worked on over the past year.

The Mayor stated he will give the VISTA's each a \$1,000 scholarship.

NB 2. ANTELOPE VALLEY TRANSIT AUTHORITY FARE SUBSIDY

The Finance Director presented the staff report regarding this matter.

Discussion among the City Council included the background leading up to this decision, and discussion of advertising "seniors ride free courtesy of the City of Lancaster" on buses; Lancaster has always supported senior citizens. Additionally, discussion took place regarding churches use of buses on Sundays and discussion of a possible bus route from Palmdale directly to the main Antelope Valley College campus.

Addressing the City Council on this matter:

Michael Rives – discussed a discount provided to commuters by the AVTA.

On a motion by Council Member Mann and seconded by Vice Mayor Crist, the City Council appropriated \$50,000 in Lancaster Proposition A funds to Account No. 207-4330-301 to the Antelope Valley Transit Authority (AVTA) as matching funds for an Antelope Valley Air Quality Management District (AVAQMD) AB 2766 grant to be awarded to AVTA contingent upon AVTA's receipt of matching funds from the AVTA member agencies and/or Antelope Valley College, for AVTA to provide free fare subsidies for Lancaster senior riders, by the following vote: 4-0-0-1; AYES: Mann, Underwood-Jacobs, Crist, Parris; NOES: None; ABSTAIN: None; ABSENT: Smith

On a motion by Council Member Mann and seconded by Vice Mayor Crist, the City Council appropriated \$50,000 in Lancaster Proposition A funds to Account No. 207-4330-301 on behalf of the City of Palmdale to the Antelope Valley Transit Authority (AVTA) as matching funds for an Antelope Valley Air Quality Management District (AVAQMD) AB 2766 grant to be awarded to AVTA contingent upon AVTA's receipt of matching funds from the AVTA member agencies and/or Antelope Valley College, for AVTA to provide free fare subsidies for Palmdale senior riders, by the following vote: 4-0-0-1; AYES: Mann, Underwood-Jacobs, Crist, Parris; NOES: None; ABSTAIN: None; ABSENT: Smith

NB 3. HIGH SPEED RAIL UPDATE

The Planning Director presented the update regarding this matter.

Discussion among the City Council and staff included discussion of the proposed alignment of the project; high speed rail will be at street level requiring overpasses to be built; plans received two years ago show alignment on the west side of the rail road tracks which will significantly impact the businesses along Sierra Highway. Discussion took place regarding the impact of overpasses on businesses and the impact on the revitalization of Lancaster's Downtown area. Additionally, the views of the area's legislative representatives, the actions the City can take regarding opposing the project and the frequency of trains coming through the area were discussed.

CR 1. REPORT ON THE ACTIVITIES OF THE BOARD OF DIRECTORS FOR DISTRICT NO. 14 OF THE COUNTY SANITATION DISTRICTS OF LOS ANGELES COUNTY

Council Member Mann stated the District is moving forward with a tax reduction in the fall.

Michael Rives – discussed Sanitation District No. 14's budget.

CR 2. REPORT ON THE ACTIVITIES OF THE BOARD OF DIRECTORS FOR THE ANTELOPE VALLEY TRANSIT AUTHORITY

Vice Mayor Crist invited the incoming AVTA Executive Director, Len Engel to speak. Mr. Engel discussed several grants awarded to the AVTA and discussed the number and types of buses that will be provided as a result of the grants. Additionally, Mr. Engel provided information regarding grant funding received to improve the infrastructure at the local facility for handling the new electric buses. The maintenance of diesel buses vs. electric buses, the number of riders the new buses can hold and MTA grants were also discussed. Mr. Engel stated AVTA will be a Lancaster Choice Energy customer.

Vice Mayor Crist discussed a meeting with the North County Transportation Coalition (NCTC) at which a possible tax increase from LA County was discussed. Additional discussion took place regarding the City of Lancaster becoming more vocal with the Los Angeles Board of Supervisors and using buses to take citizens to the Board meetings.

CR 3. COUNCIL REPORTS

Criminal Justice Commissioner Sheldon Carter discussed possible new courtrooms coming to the AV courthouse in the next couple of years, discussed a new program for reporting shoplifting - the initial businesses involved in the program will be near the eastside Walmart. Additionally Mr. Carter stated Vice Mayor Crist has invited representatives from Senator Runner and Assemblyman Lackey's offices to participate at Criminal Justice Commission meetings.

Planning Commission Chairman Vose discussed projects coming before the Commission at its meeting being held on July 20, 2015.

Mayor Parris requested that staff look at providing more youth oriented activities near The BLVD on the weekends.
