Discussion among the City Council and staff included discussion of the anticipated number of jobs for BYD, discussion of the number of available housing units in Lancaster and plans to handle future building in the City.

Michael Rives – discussed a book he recently read, stated "breaks" should not be given to the wealthy, but given to the average person.

### CA 1. DISCUSSION AND POSSIBLE ACTION TO SUPPORT SENATE CONSTITUTION AMENDMENT 8

The City Manager provided an overview of Senate Constitution Amendment 8. Additionally, Rick Cook, from Senator's Runners office discussed the next step for the Amendment.

#### CR 1. COUNCIL REPORTS

Council Member Underwood-Jacobs discussed a recent meeting with the Antelope Valley Board of Trade Transportation Committee, the AV Partners for Health ribbon cutting, the Special Olympics Torch Run, and MOAH's recent exhibit opening. Additionally the AVAQMD and AVTA meetings were discussed; both of these meetings included items related to subsidies for seniors to ride buses for free.

Fran Sereseres discussed the AVTA meeting and her discussion with a representative from Palmdale.

Additional discussion took place regarding the issue of seniors riding for free and the amount of time it has taken for Palmdale to commit to providing \$50,000 for the program; Palmdale has indicated there has not been enough time for their Council to discuss the item.

Vice Mayor Crist discussed the actions being taken as a result of the program passing despite Palmdale representative's voting against it; representatives from AVTA will go to the Senior Center to assist with providing 'TAP' cards – this will keep the seniors from having to go to AVTA to obtain the cards.

Council Member Mann discussed the AVAQMD Board meeting, discussed comments made by a Palmdale representative at a recent meeting and discussed the timing of Palmdale's Council meetings as it relates to the timing of the issue regarding providing subsidies for seniors using Proposition A funds.

Fran Sereseres – discussed her attendance at the AVTA meeting at which she thanked the City Council for their action in contributing money for the seniors to ride free; discussed the recent street paving and the proposed increase from Waste Management.

The City Manager discussed the product used to pave the streets, stated this project was to repave the streets, not reconstruct the streets; the intent is to extend the life of the road and to prevent potholes from occurring.

Ron & Yvette Emard thanked the City Council for their support for the Thunder on the Lot event; thanked staff for all the hard work; stated they are looking forward to next year's event and the partnership with the City.

Randi Bardeaux – thanked the City Council for providing all seniors with the availability to ride buses for free; thanked Fran Sereseres for her work done on behalf of seniors.

#### PUBLIC BUSINESS FROM THE FLOOR - NON-AGENDIZED ITEMS CONTINUED...

David Paul – discussed an economist he respects and a book the economist wrote, discussed NB 1 and the effect not paying fees will have on unfinished projects.

Michael Rives – thanked the City Manager's office for their help with landscaping at a local business; thanked Council Member Underwood-Jacobs for her work regarding bus shelters; commended Vice Mayor Crist for conducting the meeting at AVTA; thanked Mayor Parris for his openness for people to speak at meetings. Vice Mayor Crist clarified the actions taken by the AVTA regarding seniors riding buses for free; the existing program allowing senior citizens to ride for free will end on September 1<sup>st</sup>, the new subsidy with the use of 'TAP' cards goes into effect on September 1<sup>st</sup> – senior citizens and disabled individuals will continue to ride for free.

Wally Melendez – discussed dirty bus seats; suggests moving elections to even numbered years.
