

RESOLUTION NO. 15-50

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, AMENDING RESOLUTION NO. 15-29 REVISING THE ESTABLISHED CITYWIDE FEE SCHEDULE AND ESTABLISHING PARKING BAIL AMOUNTS AND A BAIL AND FINE SCHEDULE

WHEREAS, the City Council, on June 23, 2015, adopted Resolution 15-29 establishing a Citywide Fee Schedule; and

WHEREAS, the City seeks to lower the fee for Wi-Fi use at the Lancaster Museum of Art and History (MOAH); and

WHEREAS, civil penalties for parking violations are authorized by the California Vehicle Code and Lancaster Parking Citation Processing Ordinance No. 643, codified in Chapter 10.16 of the Lancaster Municipal Code; and

WHEREAS, the City of Lancaster's Parking Bail Schedule includes, in part, fees mandated by Government Code (GC) 76000(b), 76100, 76101, 70372(b), Penal Code (PC) 1463.28, 1465.5, Vehicle Code (VC) 40200.3, 40225(d) and PC 1465.6 adopted by the City of Lancaster, in addition to base penalty fees, administrative fees, and late fees; and

WHEREAS, the City desires to amend the Lancaster Museum of Art and History (MOAH) Wi-Fi use fee, Part IV – Community Safety, Section 3: Parking Bail Amounts and Part V – Bail and Fine Schedule as part of Attachment A to Resolution No. 15-29.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LANCASTER AS FOLLOWS:

Section 1. Fees for the following services are hereby established in the amounts set forth in Attachment A.

Section 2. Fees will be adjusted annually, effective each October 1, based on the prior Los Angeles-Riverside-Orange Co – All Urban Consumers (CPI-U) annual average percent change.

Section 3. The effective date of this Resolution shall be October 1, 2015.

Section 4. Any Resolutions in conflict with provisions stated herein shall be considered superseded by the provisions contained with this Resolution.

**C. Late Payment Penalty**

Late payment penalty and administrative fees shall attach to the Base Penalty if the Base Penalty is not paid within twenty-one (21) days of issuance of the Notice of Parking Violation.

**D. Total Penalty**

The total parking penalty includes the Base Penalty, other special penalties and charges as provided in the California Government Code, California Penal Code, and California Vehicle Code; any Late Payment Penalty; and all Administrative Fees, assessments and costs of collection as provided by law pursuant to the California Vehicle Code Section 40200.3(f)
