Drought and Conservation Efforts Update

Presenters: Craig David, Los Angeles County Waterworks District Area Engineer and David Rydman, Los Angeles County Department of Public Works Water Resource Manager

Discussion among the City Council and Mr. Rydman included discussion of the funds collected for excess water use – these funds are funding conservation programs. Discussion took place regarding the specific ways customers are reducing their water consumption. Mr. Rydman stated Los Angeles County Waterworks District 40 was identified as an area with "remarkable performance in reduction in California" for June 2015. Additional discussion took place regarding water allocation through the winter months.

Additional discussion took place regarding merging Los Angeles County Waterworks and the Los Angeles County Sanitation District. Mayor Parris requested a response be provided to the City Council in 30 days as to when an analysis would be completed to determine if a merger is cost effective or should be pursued.
