RESOLUTION NO. 15-64

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, DECLARING ITS INTENTION TO AMEND RESOLUTION NO. 13-46, EXTENDING THE TIME WITHIN WHICH WORK IN UNDERGROUND UTILITY DISTRICT NO. 2013-01 IS TO BE COMPLETED

- WHEREAS, on July 23, 2013, the City Council of the City of Lancaster adopted Resolution No. 13-46, creating Underground Utility District No. 2013-01 in accordance with the provisions set forth in Chapter 13.20 of the Lancaster Municipal Code; and
- WHEREAS, Resolution No. 13-46 set the time within which utility poles, overhead wires and associated structures were to be removed and underground installation of electric, communication and similar or associated service was to be completed; and
- WHEREAS, staff has determined that additional time is necessary for completion of the overhead removal and underground installation work in Underground Utility District No. 2013-01; and
- WHEREAS, the City Council of the City of Lancaster finds that undergrounding of electric, communication and similar or associated service will avoid or eliminate an unusually heavy concentration of overhead electric facilities; and
- WHEREAS, the City Council of the City of Lancaster further finds that the street right-of-way within Underground Utility District No. 2013-01 is extensively used by the general public and carries a heavy volume of vehicular traffic.
- NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LANCASTER DOES HEREBY RESOLVE AS FOLLOWS:
- Section 1. The foregoing recitals are true and correct and are a substantive part of this Resolution.
- Section 2. It is ordered that by March 31, 2019, all electric, communication and similar or associated service overhead distribution facilities, shall be removed from Underground Utility District No. 2013-01, and the underground installation of such distribution facilities shall have been accomplished in said District.
 - Section 3. This resolution shall take effect immediately upon its passage.
