Discussion between the Council and staff included discussion of the Amargosa Creek design; after discussion among the City Council and staff, the City Council found that as a result of this past storm, immediate action is necessary to complete the drainage system capital projects and work needs to begin without delay because if there is another powerful storm before the projects are completed, even if it's not a 1,000 year storm, we could have additional significant mud and water flow that could pose a hazard to life-safety and cause serious damage to public and private property.
