SUBJECT: Report on the Activities of the Board of Directors for District No. 14 of the

County Sanitation Districts of Los Angeles County

Recommendation:

Receive a report of the proceedings and issues discussed at the January 21, 2016 District No. 14 Board of Directors meeting of the County Sanitation Districts of Los Angeles County (District).

Background:

District No. 14 of the County Sanitation Districts of Los Angeles County is organized to receive through their trunk sewers the wastewater from all of the City of Lancaster, a small region of the westerly portion of the City of Palmdale, and a smaller region of the unincorporated County of Los Angeles. A Board of Directors comprised of a representative from each city and the County generally meets monthly to review and decide upon the business of the District.

The Board of Directors considered the following agenda items at the January 21, 2016 meeting:

- Approved minutes of meeting held December 8, 2015.
- Approved warrants in the amount of \$3,838,176.69 for the months of November and December, 2015. The warrants issued by the District are for costs incurred for operation and maintenance, such as electricity, water, telephone, and chemicals, and for relatively small capital projects. Expenditures are made in accordance with the guidelines established by the budget procedure and the purchasing policy that has been adopted by the Board.
- Reported on Bids and Award of Contract for Construction of Lancaster Water Reclamation Plant Inlet Works Electrical Upgrades.
