## RESOLUTION NO. 16-09

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, AUTHORIZING THE CITY MANAGET TO ADJUST THE 2016 MARKET DEMAND CREDIT FOR LANCASTER CHOICE ENERGY

- WHEREAS, the City Council adopted Ordinance 997 declaring its intent to establish a Community Choice Aggregation (CCA) program; and
- WHEREAS, the City Council approved an Implementation Plan to establish a Community Choice Aggregation Program; and
- WHEREAS, the Implementation Plan was certified by the California Public Utilities Commission on October 16, 2014; and
- WHEREAS, Lancaster Choice Energy (LCE) was registered as an energy provider on October 31, 2014; and
- WHEREAS, City Council adopted Resolution No. 15-70 establishing power generation rates for customers of LCE effective January 2016; and
- WHEREAS, the rate schedule included a 2016 Market Demand Credit to provide flexibility in remaining competitive with the marketplace; and
- WHEREAS, the City Council has established a goal of providing an average 3% savings to LCE customers for energy generation rates compared to Southern California Edison; and
- WHEREAS, the instability of the rate environment results in a need for flexibility to achieve the savings goals as established.
- NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LANCASTER AS FOLLOWS:
- Section 1. Authorize the City Manager to adjust the 2016 Market Demand Credit to maintain and achieve the City Council's stated goal of providing an average 3% savings to Lancaster Choice Energy customers for energy generation as compared to Southern California Edison
- Section 3. The City Manager shall bring such adjustments to the City Council for ratification at its earliest available, properly noticed, City Council meeting.
  - Section 2. This resolution shall be effective immediately.
