RESOLUTION NO. 16-15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 12, 2016 AND DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Lancaster, California, on Tuesday, April 12, 2016 as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in charter cities; and

WHEREAS, the City Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The whole number of votes cast in the precincts except vote by mail voter ballots and provisional ballots was 1522.

SECTION 2. The whole number of vote by mail voter ballots cast in the City was 5996, the whole number of provisional ballots cast in the City, including vote by mail ballots turned in at precincts was 766, making a total of 8284 votes cast in the City.

SECTION 3. The total percentage of voter turnout was 11.2 %.

SECTION 4. The names of the persons voted for at the election for Mayor are as follows:

SECTION 4. The names of the persons voted for at the election for Member of the City Council are as follows:

SECTION 5. The number of votes given at each precinct and the number of votes given in the City to each of the persons named above for the respective offices for which the persons were candidates are as listed in "Exhibit A" attached.

SECTION 6. The City Council does declare and determine that:

- R. Rex Parris was elected as Mayor for the full term of four years
- Ken Mann was elected as Member of the City Council for the full term of four years
- Angela Underwood-Jacobs was elected as Member of the City Council for the full term of four years.

SECTION 7. The City Clerk shall enter in the records of the City Council of the City, a statement of the result of the election, showing: (1) the whole number of votes cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; (4) the number of votes given at each precinct to each person; (5) the total number of votes given to each person.

SECTION 8. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 9. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
