APPROVAL OF LANCASTER HEALTHY COMMUNITY COMMISSION CONSENT CALENDAR

CC 1. MINUTES

COMMISSION PRESENTATIONS, DISCUSSION & DIRECTION

1. JUDGE CHRISTOPHER ESTES

Judge Christopher Estes, Deputy Public Defender John Henderson, and Deputy District Attorney Dennis Vincent provided background information on the structure of Judge Estes' Felony Trial Court including overview of the Drug Court Program, and case assessment and processing.

Commission Member Wiley arrived at the meeting at this time.

Discussion among the Commission, Judge Estes, Mr. Henderson, Mr. Vincent and staff included cases being processed through the Drug Court Program, case assessment process, resources in place, expansion of the court program established in the Antelope Valley, transition process, future need for additional resources, and possible future steps to take.

2. LOS ANGELES COUNTY DEPARTMENT OF PUBLIC HEALTH

Dr. Tina Kim, Chief of the Health Outcomes and Data Analytics for SAPC, presented her data report on Substance Use/Abuse for Service Planning Area (SPA) 1.

Antoine Moore, Chief Marketing & Beneficiary for the Strategic Network & Development for SAPC, and Yanira Lima, Chief of the Adult Systems of Care Division for SAPC, provided information on what substance use treatment services are available including an overview of client engagement and navigation.

Discussion among the Commission, Ms. Moore, Ms. Lima, and staff included partnerships throughout the County, facilities and resources available, expansion of services, how to locate available services, Measure H funds, recovery bridge housing, funding sources and potential future expansion.

3. MENTAL HEALTH AMERICA OF LOS ANGELES

Judy Cooperberg, Chief Advancement Officer for North County, and John Glover, Licensed Clinical Social Worker and Team Leader, provided background information on the establishment of Mental Health America (MHA) in the Antelope Valley, and information on MHA's recovery model followed, funding, services provided, expansion of services, future collaborations, substance abuse, homelessness, mental health, and community outreach.

Discussion among the Commission, Ms. Cooperberg, Mr. Glover, and staff included substance abuse, daily encounters, annual service data, full service partnership, mental health, program success, Golden Bell Awards in October, and possible future steps to take.

4. TARZANA TREATMENT CENTER

Alesia Ping-DiFiore, Program Director for 10th Street Programs, and Joshua Price, Substance Use Counselor and Drug Court Liaison, provided information on services provided including residential and outpatient services, primary care, bridge housing, current and future needs, youth programs, substance abuse programs, mental health programs and wraparound programs.

Discussion among the Commission, Ms. Ping-DiFiore, Mr. Price, and staff included waiting period for services, steps taken, daily encounters, other local service providers and organizations, available beds, intake data, mental health, recovery bridge housing, support services, funding and possible future steps to take.

5. GENERAL DISCUSSION ON THE NEXT STEPS

Discussion among the Commission, and staff included mental health, substance abuse, possible fixes to the current systems in place, newly funded mental health urgent care, and viable options for the needs identified e.g., housing, beds, prevention, etc. Staff will work on scheduling the local California Legislative Offices for attendance at the next commission meeting.
