#### APPROVAL OF CRIMINAL JUSTICE COMMISSION CONSENT CALENDAR

#### **COMMISSION/ STAFF UPDATES**

#### 1. LOS ANGELES COUNTY SHERIFF'S DEPARTMENT CRIME TRENDS REPORT

Deputy Deciga provided statistics along with additional information for August 2018 for the Burglary Suppression Team, the LAN-CAP Team and the Robbery Team. Additionally, Deputy Deciga provided information for August 2018 for the LEAPS program.

The Los Angeles County Sheriff's Department has continued with their Community Engagement with the following activities, Coffee with Vets, Kinder Care Presentation, Monthly Coffee with a Deputy, and National Night Out.

Discussion among the Commission, Deputy Deciga and staff included the domestic violence and grand theft auto statistics provided.

#### 2. LOS ANGELES COUNTY PROBATION DEPARTMENT UPDATE

Department Supervisor, Robert Sepulveda, provided AB 109 case statistics for the month of September 2018 for violations, sanctions, flash incarcerations, Department of Mental Health referrals, Tarzana Treatment Center referrals, and home contact compliance checks. The provided statistics include Lancaster, Palmdale, Lake Los Angeles, Acton, up to the borders of San Bernardino County and Kern County.

Discussion among the Commission, Mr. Sepulveda and staff included the statistics provided for home contact compliance checks, referrals, violations, laws governing the implementation of AB 109, staffing and what's being encountered.

#### 3. CALIFORNIA HIGHWAY PATROL UPDATE

Captain Broneer of the California Highway Patrol provided statistics through the end of September 2018 along with a comparison to September 2017 for fatal accidents, traffic collisions, DUI related accidents, total arrests, motor vehicle thefts and staffing.

Discussion among the Commission, Captain Broneer, and staff included the statistics provided for fatal accidents, DUI related accidents, coordination of activities between Cal Trans and the City's Traffic Engineering Department, motor vehicle thefts, possible correlation of activities to AB 109, State and County activities affecting the community and what can be done at a local level for public safety.

#### 4. DISTRICT ATTORNEY UPDATE

Deputy District Attorney Robert Sherwood provided felony and misdemeanor filing statistics through August 2018 along with a comparison to the last year, and notice of recent changes to misdemeanor filings for illegal camping citations issued.

Discussion among the Commission, Deputy District Attorney Sherwood, and staff included the recent changes to misdemeanor filings for illegal camping citations issued.

#### 5. CITY ATTORNEY UPDATE

The Assistant City Attorney provided an update on SB 946 pertaining to sidewalk vendors and possible changes to regulations including update on monthly activities for the legal department.

Discussion among the Commission and staff included the possible impacts of SB 946 to the community, and nuisance property update. Staff will work on scheduling a representative from the Los Angeles County Health Department to attend a future commission meeting to present more information on SB 946.

#### 6. PUBLIC SAFETY UPDATE

The Public Safety Director provided an update on the activities of the Quality of Life Crew, implementation of a new program with the Los Angeles County Police Department, resource management and public safety.

Additionally, Mr. D'Errico discussed the success of the City's past community events and provided information on the City's upcoming BooLVD event scheduled for October 27, 2018, which he invited everyone to attend.

#### 7. STATE LEGISLATIVE OFFICE UPDATE

Russell Williams from Assemblyman Tom Lackey's office provided state legislative updates which included SB 1437, and information on a self defense workshop for women on October 15, 2018 at Antelope Valley Partners for Health.

Marva Greenleaf – discussed her intentions for the greater good, scheduling of the gun shows including the tax revenues from the shows, what she has experienced within the community, domestic violence, domestic terrorism, her volunteer work and community pride.

# LEAPS PROGRESS REPORT





LAW ENFORCEMENT AERIAL PLATFORM SYSTEM (LEAPS) PROVIDES AERIAL OBSERVATION SURVEILLANCE FOR THE CITY OF LANCASTER AND THE LASD

During September 2018, LASD formally logged 85 LEAPS service calls supporting tactical field operations. LEAPS was dispatched 117 times totaling 28.4 hours and was airborne providing strategic surveillance for 263.3 hours.

LEAPS provided airborne observation and support in the arrest of 14 suspects. Notable incidents during the month of September included aerial surveillance and support of deputies during searches for several missing persons. LEAPS also provided vital early overhead observation for deputies during calls of persons with firearms and during approaches to several parked stolen vehicles.

LASD sworn deputies are utilized as LEAPS ground system operators. Operators are able to easily search for and obtain recorded video from the LEAPS system to aid in criminal prosecutions. For more information regarding LEAPS, please visit www.aeroviewllc.com.

In addition to providing a force multiplier to the LASD in support of criminal activity suppression and deterrence, and search and rescue support, the LEAPS activity returns 99% of its revenue to the Lancaster community in the form of (1) salaries for pilots and systems support staff, (2) ongoing support from businesses at Fox Field for airframe maintenance and FAA compliance, avionics support and fuel, (3) ongoing support from local Lancaster businesses for purchasing and fabrication of LEAPS components and subsystems, and (4) local taxes and fees. This is further underpinned by Aero View LLC's commitment to remain headquartered in Lancaster for ten years. Taxes and fees account for less than 1% of costs. The LEAPS also provides the City of Lancaster with tactical and strategic reconnaissance support for (1) civic functions and activities, (2) emergency first responder support and (3) Department of Public Safety activities.

AeroView operates the LEAPS aircraft seven days a week 365 days a year for the City of Lancaster.
