COMMISSION PRESENTATIONS, DISCUSSION & DIRECTION

1. 2019 Homeless Count Numbers by Community/City Presented by: Los Angeles Homeless Services Authority (LAHSA) Timothy KirkConnell, Coordinator, Community Engagement

Countywide, there were 3,886 homeless veterans in 2018. The number decreased to 3,874 homeless veterans in 2019. The County housed another 2,824 veterans in 2018. The Antelope Valley's homeless veteran population decreased 53% from 2018 to 118 veterans this year, including 12 chronically homeless. The number of family members experiencing homelessness increased 6.4% countywide, while the number of people experiencing chronic homelessness increased 17%. Homelessness among the youth increased 24%, while homelessness among seniors increased by about 8%. The majority, or 53%, of people experiencing first-time homelessness cited economic hardship as a leading factor. An estimated 5% of people reported experiencing homelessness because they were fleeing domestic violence/intimate partner abuse. Of those, 89% are adults. The majority or 54.8% are women, 43.1% are men, and 2.1% are transgender. Another 29% of people experiencing homelessness reported a serious mental illness and/or substance use disorder. Approximately 64.9% of people experiencing homelessness have lived in L.A. County for more than 10 years. The remaining 35.1% come from other counties in southern California or the state, or even out of state.

LAHSA has been recording the homeless number by census tract; and numbers that come back are census track base, we assign these census track base based on what the City boundaries are.

"What are we doing to making sure we are not double counting; what are we using to make sure we are not counting the same person twice?" Commissioner Nigel Holly asked.

KirkConnell the way that homeless count is structured is that we cover a specific set out area all at the same time, we usually go out to count when people are either going to bed or just waking up which is typically what happens in the Antelope Valley. In most of Los Angeles County, the count is conducted at 10pm and the assumption is that we will catch most people as they are going back to their tent or provided housing, and that should prevent the double counting. The way we allocate the regions we count we do it by service planning; SPA's2 and 3 operate on the same evening, if they would be counted twice in those two areas they would be caught that night.

2. Update on Homeless Impact Study Session / Presented by: Melissa Varela

The Vision of the Lancaster Homeless Impact Commission; First year review. In the first year, the Homeless Commission Formed, Measure H Funding secured; Kensington Campus; Capacity building with Social Services providers.

Goals for the next year:

- A one-stop-shop of resources much like 211LA however more specific to Lancaster. An
 opportunity to create a place for services/organizations ensuring that duplicative efforts are
 not occurring and allows for easy access.
- Research housing and shared living options for seniors and transitional aged youth (TAY).
- Identify a measurable community goal that is focused on prevention and/or housing.

3. LAHOP – Description of Services and How to use them / Presented by: Jacqueline Beltran, CES Outreach Coordinator

The Los Angeles County Homeless Outreach Portal, also known as LA-HOP, provides a streamlined countywide web-based portal designed to assist people experiencing homelessness in L.A. County with voluntary outreach services.

LA-HOP is designed to allow users to submit requests for homeless outreach. After a request is submitted, an outreach coordinator reviews the request, designates a priority level, and assigns it to an outreach team. The team lead assigns the request to the appropriate team member, who then connects with the homeless individual.

In the City of Lancaster, there were 123 requests over the past year, of which 113 are closed, seven open, four under review, and three need follow-up. Requests in the City are typically assigned in one day with an average of 18 days for an outreach worker to connect with the homeless individual.

Vice Chair Sgt. Teresa Dawson asked why it took up to 18 days to close out some requests.

Beltran said that of the 123 requests in the City of Lancaster there were about three requests open for longer than 60 days, which increased the average time to 18 days.

"Is it that we need more outreach workers in the community? Is that why we're not reaching as many people are we possibly could?" Commissioner Nigel Holly asked.

"For Service Planning Area 1 I don't think it's the teams, it's more the lack of housing resources and the ability to connect clients to bridge housing, any sort of shelter," Beltran said. "There's very limited resources in this area. ...There's a bottleneck, there's no resources to connect them to."

Sgt. Dawson of the Lancaster Sheriff's Station said there needs to be more education about LA-HOP, in particular with first responders.

"I have never heard of this program until I became involved with the homeless," Dawson said. "We're not being taught this. We're not being showed this, and there hasn't been any presentations at our stations."

Dawson added they come across the homeless every day.

"If an effort can be made to come to the stations, I can help you coordinate that," Dawson said.

"I think the ultimate goal is we want to connect the community to the resource," Holly said.

Addressing the Commission on this item

David Paul – Went through the coordinated entry system training and he has never heard of LAHOP; he shares is frustration with the community. There is not one person that represents the homeless; feels like we are going in circles. He appreciates what the City and Commission do.
