2. Zone Text Amendments

5. Conditional Use Permit No. 19-15

Planning Intern, Jacob Swiech, presented the staff report.

Chairman Vose asked if Condition #19 was deleted from the Conditions List, as discussed in the Special Agenda Meeting, and Jacob Swiech confirmed it was.

Commissioner Parris made a motion, and Vice Chair Smith seconded the motion to adopt Resolution 19-34 approving Conditional Use Permit No. 19-15 to allow a Type 47 (on-sale general for a bona fide restaurant) Alcoholic Beverage Control (ABC) license in an existing tenant space (La Papillon Steak and Seafood) and entertainment in the Commerce District of the Downtown Lancaster Specific Plan (SP 08-01) zoning designation, located at 858 West Lancaster Blvd.

3. Wireless Ordinance
