CC4. PROFESSIONAL SERVICES AGREEEMENT-PREPERATION OF HOUSING ELEMENT AND OTHER REQUIRED GENERAL PLAN

Approved award of Additional Authorization No. 1 to Moore Iacofano Goltsman, Inc., (MIG) of Pasadena, California, to amend and increase the Professional Services Agreement in the amount of \$100,177.00 to prepare the Housing Element and other required updates to the existing General Plan. Authorized the City Manager, or his designee, to sign all documents.

CC 5. CDBG SUBRECIPIENT AGREEMENT BETWEEN THE CITY OF LANCASTER AND THE PEOPLE CONCERN TO PROVIDE FUNDING FOR KENSINGTON CAMPUS INFRASTRUCTURE

Discussion among Council included: concerns with phone call received informing bus load of people in a metro bus that where dropped off at Kensington location; whether persons that were brought to the Antelope Valley were from Los Angeles County; usage of metro bus to bring individuals from LA County to Kensington.

Deputy Mayor Varden discussed SPA 1 residents; researching to find out if there are exceptions; forty-four percent increase in homelessness since last year; operation room key possibly reason for transport of individuals.

Vice Mayor Crist discussed difference in number of people brought; metro bus usage if individuals where SPA 1; enough persons in Lancaster in need to use available beds; Valley Oasis' role in helping locate homeless.

Council Member Mann discussed solution to Lancaster not other areas.

City Manager discussed comment that was made to SPA 1.

Mayor Parris discussed agreement being used for Lancaster not SPA 1; significant investments and taking care of Lancaster first.

Mayor Parris pulled item No. CC 5 until further inquiry is complete.
