PH 1. AMENDMENT TO CHAPTER 9.48 OF THE LANCASTER MUNICIPAL CODE RELATING TO ADMINISTRATIVE DIVERSION FOR MISDEMEANOR OFFENSES; AMENDMENT TO CHAPTER 1.16 AND 17.42 OF THE LANCASTER MUNICIPAL CODE RELATING TO APPEAL PROCEDURES FOR ADMINISTRATIVE CITATIONS

Fernando Nunez-spoke in opposition of Ordinance 1079; discussed targeting different members of the population.

Ron Kagen- spoke in opposition of Ordinance 1079 (against); discussed animosity toward ACLU and financial implications.

Jason Jones-spoke in opposition of Ordinance 1079; discussed effects on homeless community.

Sylvia Garner- spoke in opposition of Ordinance 1079; discussed financial impact on homeless.

David Abber- discussed issues at Kensington Campus.

Kimberly- discussed impacts to homeless community and quality of life issues.
