CALIFORNIA CHOICE ENERGY AUTHORITY - CONSENT CALENDAR

CCEA CC 1.Approve California Choice Energy Authority Entering into a Long-Term Renewable Energy Contract with Powerex Corporation on behalf of Baldwin Park Resident Owned Utility District and Pomona Choice Energy

Recommendation:

- 1. Approve California Choice Energy Authority entering into a long-term renewable energy contract with Powerex Corporation on behalf of Baldwin Park Resident Owned Utility District.
- 2. Approve California Choice Energy Authority entering into a long-term renewable energy contract with Powerex Corporation. on behalf of Pomona Choice Energy.

CalChoice and its legal and technical team spent several months negotiating and finalizing commercial and contract terms with Powerex Corporation (Powerex) on behalf of its member agencies. The energy delivered under this contract will be wind and biomass from the Pacific Northwest, and delivery will begin July 2021 for a period of ten years. As a condition of the contract, payment terms are such that each member city's general fund

is protected, and no additional credit or collateral is required by Baldwin Park Resident Utility District (BPROUD) and Pomona Choice energy (Pomona Choice) or CalChoice.

Recommendation:

Accept the work constructed by R.C. Becker and Son, Inc. for PWCP 17-014 REBID - Avenue I Improvements, Challenger Way to Price Lane, HSIPL-5419(047), and direct the City Clerk to file the Notice of Completion. Retention on this project shall be disbursed in accordance with California Public Contract Code.

On March 24, 2020, City Council awarded PWCP 17-014 REBID - Avenue I Improvements, Challenger Way to Price Lane, HSIPL-5419(047). This project provided minor pavement widening and shoulder paving on Avenue I, between Challenger Way and Price Lane, and provided new bike lanes and striped buffer, curb separated Asphalt Concrete (AC) pedestrian walkways, Portland Cement Concrete (PCC) curb, gutter, meandering sidewalk, driveways, new street lighting, and ADA compliant PCC curb ramps and AC landings. The project installed bus stop amenities at existing bus stops, re-sign and re-stripe, and modified existing medians. This project was primarily funded with Highway Safety Improvements Program (HSIP) grant funds for Construction Engineering and Construction.

CC 4. Acceptance of PWCP 17-015 REBID - Avenue I Improvements, Price Lane to 35th Street East, HSIPL-5419(048)

Recommendation:

Accept the work constructed by R.C. Becker and Son, Inc., for PWCP 17-015 REBID - Avenue I Improvements, Price Lane to 35th Street East, HSIPL-5419(048), and direct the City Clerk to file the Notice of Completion for the project. Retention on this project will be disbursed in accordance with California Public Contract Code.

On March 24, 2020, City Council awarded PWCP 17-015 REBID - Avenue I Improvements, Price Lane to 35th Street East, HSIPL-5419(048). The project provided minor pavement widening and shoulder paving on Avenue I, between Price Lane and 35th Street East, and provided new bike lanes and striped buffer; curb separated Asphalt Concrete (AC) pedestrian walkways; Portland Cement Concrete (PCC) curb, gutter, and sidewalk; new street lighting; and ADA compliant PCC curb ramps and AC landings. The project installed bus stop amenities at existing bus stops, re-sign and re-stripe. This project was primarily funded with Highway Safety Improvements Program (HSIP) grant funds for Construction Engineering and Construction

CC 5. Award of Bid – PWCP 19-002 - 10th Street West and Avenue J Improvements, HSIPL-5419(053)

Recommendation:

- 1. Award PWCP 19-002 10th Street West and Avenue J Improvements, HSIPL-5419(053), to Los Angeles Engineering, Inc., of Covina, California, in the amount of \$2,615,000.00 plus a 10% contingency to construct pedestrian and bicycle improvements. Authorize the City Manager, or his designee, to sign all documents. This contract is awarded to the lowest responsible bidder per California Public Code Section 22038 (b).
- 2. Approve a budget transfer from Capital Improvements Budget Account Number 209-12ST046-924 (2021 Summer Pavement Management Program) in the amount of \$363,000.00, to Capital Improvements Budget Account Number 209-12ST039-924 (PWCP 19-002, 10th Street West and Avenue J Improvements, HSIPL-5419(053)).

The proposed project is funded by the State of California, Department of Transportation (Caltrans) Highway Safety Improvements Program (HSIP) and local matching funds, including gas tax funds, TDA Article 3 funds, TDA Article 8 funds, Proposition C funds, Measure R funds, and Traffic Impact fees. This project will include typical pedestrian and bicycle improvements to construct curb, gutter, sidewalk, and ADA curb ramps with curb extensions and/or bulbouts, traffic signal modifications, minor street widening, pavement repair, street trees removal, bus stop modifications, and existing driveway apron replacements with ADA compliant aprons.

The existing striping will be removed and replaced with new striping along the entire project corridor to accommodate new bike lanes with painted buffered lane. The proposed project is approximately 2.68 miles in length on two (2) major arterial streets, Avenue J and 10th Street West.

CC 6. Acceptance of PWCP 20-002 - 2020 Sewer Rehabilitation Project

Recommendation:

Accept the work constructed by Mike Prlich & Sons, Inc., for PWCP 20-002 - 2020 Sewer Rehabilitation Project, and direct the City Clerk to file the Notice of Completion for the project. Retention on this project will be disbursed in accordance with California Public Contact Code.

This project provided uncovering, raising and adjusting to grade existing buried manholes at thirty-four (34) separate locations, and removed and replaced manhole frame and covers with new 28" PAMREX manhole frame and covers. Removed and replaced 8" VCP sewer main line at three (3) different locations, that included saw cutting, removal of asphalt/base, excavating to pipe, trench shoring, cutting the section of pipe removed and replaced and reinstated all laterals, wyes and concrete encasement that were affected by the removals. Sectional point repairs by installation of Cured-in-Place-Pipe (CIPP) lining for existing 8" VCP sewer main line at two (2) separate locations. Installation of Cured-in-Place-Pipe (CIPP) lining for existing 8" VCP sewer main line, from manhole to manhole segment at four (4) different locations.

CC 7. Acceptance of PWCP 20-003 - 2019 Sidewalk, Curb and Gutter Repairs

Recommendation:

Accept the work constructed by DOD Construction, for PWCP 20-003, 2019 Sidewalk, Curb and Gutter Repairs, and direct the City Clerk to file the Notice of Completion for the project. Retention on this project will be disbursed in accordance with the California Public Contract Code.

In May 2019, the City of Lancaster adopted Resolution No. 19-17 to move forward with the issuance of revenue bonds, series 2019 (Measure M & R Street Improvement Projects) to accelerate the completion of major road improvement projects located throughout the City's urban core. In October 2019, the City executed a Bond Purchase Agreement with the bond proceeds being allocated to multiple road improvement projects that will go to construction over the next three years. The 2019 Sidewalk, Curb and Gutter Repairs project is part of the first phase of bond funded, road improvement projects, and will repair, replace or construct 21,000 SF of concrete, repair 3,100 linear feet (LF) of curb and gutter, and 4,900 SF of cross gutters and spandrels. The project also includes trimming sixty-four (64) trees. This will help improve the health of the trees and improve the overall appearance. In addition, the City will improve 100 curb ramps in compliance with the City of Lancaster's 2014 ADA Transition Plan.

CC 8. Acceptance of PWCP 21-004 - 42nd Street West and Avenue K Drainage Improvements

Recommendation:

Accept the work constructed by R.C. Becker and Son, Inc. for Public Works Construction Project No. 21-004, 42nd Street West and Avenue K Drainage Improvements, and direct the City Clerk to file the Notice of Completion. Retention on this project shall be disbursed in accordance with California Public Contract Code.

On June 23, 2020, the City Council awarded PWCP 21-004, 42nd Street West and Avenue K Drainage Improvements. This project rehabilitated the north side of existing street on Avenue K between 40th Street West and 42nd Street West while maintaining the existing overland drainage flow pattern. The project included, but was not limited to, full depth pavement reconstruction with Cement Treated Base (CTB), installation of thickened edge of pavement, shoulder grading, manhole adjustment and striping.

CC 9. 2021-2022 Road Maintenance and Rehabilitation Account (RMRA) Project List for Senate Bill 1, The Road Repair and Accountability Act of 2017

Recommendation:

Adopt **Resolution No. 21-26**, approving Senate Bill 1 (SB 1) Proposed Project List Form and allocate funds in the fiscal year 2021-2022 Capital Improvement Budget to clarify Road Maintenance and Rehabilitation Account (RMRA) funded projects.

SB 1 emphasizes the importance of accountability and transparency, therefore, in order to be eligible for RMRA funding, statue requires cities adopt a proposed project list at a regular public meeting. The list of proposed projects must include a description and location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement. Cities must also adopt RMRA funded projects into a city's operating or capital improvement budget. Cities must then submit the completed SB 1 Proposed Project List form to the California Transportation Commission (CATC), in order to receive its apportionment of RMRA funds from the State Controller.2021.

CC 10. Acceptance of Road Easement (Offer of Dedication) Located on the South Side of Avenue J-4 Between 32nd Street East and 35th Street East

Recommendation:

Adopt **Resolution No. 21-27**, a resolution of the City Council of the City of Lancaster, California, accepting a portion of an offer of dedication for street rights-of-way namely the south side of Avenue J-4 between 32nd Street East and 35th Street East.

An offer of dedication for rights-of-way was made for streets within Parcel Map No. 11750, recorded on April 3, 1979, in Parcel Map Book 109, pages 21 and 22, in the Office of the County Recorder of Los Angeles County. At that time, the City Council rejected that offer. One of those streets located over the northerly 32 feet of Parcel 2 of said map, is shown as the south side of Avenue J-4 (between 32nd Street East and 35th Street East). This right-of-way dedication has been conditioned by the Planning Commission for Tentative Tract Map 61278. Therefore, the Development Services Director has reviewed and recommended this street be accepted for public street purposes. With this resolution, the City would accept that portion of the Offer of Dedication as described above. The resolution will be recorded in the Office of the County Recorder. The City is permitted by law to accept offers of dedication. The subject easement will be used for public ingress/egress once the Offer of Dedication is accepted.

CC 11. Task Order for Multi-Year Traffic Engineering, Planning, and Related Professional Services (Service Group Category 2 – Strategic Transportation Planning) for Safe Routes to School Master Plan Refresh

Recommendation:

Approve Task Order No. 1 with Redman Consulting, LLC, of West Linn, OR, for services, in accordance with the Multi-Year Traffic Engineering, Planning, and Related Professional Services Agreement, Service Group Category (SGC) 2 – Strategic Transportation Planning, to update the City's Safe Routes to School Master Plan, in the amount of \$215,975.00; and authorize the City Manager, or his designee, to sign all documents.

During the process of City staff working on an Active Transportation Program Cycle 5 application for a Safe Routes to School capital improvement project it was determined that due to significant changes to the built environment, school attendance zones, the economy, local

work and travel patterns, and demographics, the City's Safe Routes to School Master Plan needs to be updated.

CC 12. Memorandum of Understanding with TRU 2005 RE I, LLC

Recommendation:

- 1. Approve a Memorandum of Understanding with TRU 2005 RE I, LLC related to the proposed development of the former Toys "R" Us center on the northeast corner of Avenue K and 15th Street West.
- 2. Authorize the City Manager or his designee to finalize and execute all related documents.

The proposed Memorandum of Understanding ("MOU") would memorialize a number of items that have been discussed in order to advance the development of the site, which include:

- The City's street improvements and installation of a traffic signal associated with the Avenue K freeway interchange project, previously budgeted as part of the City's various grant-funded interchange projects
- Expedited permitting as a key economic development project
- A commitment to collaborate in good faith on a "Welcome Feature" and signage to promote both the City of Lancaster, as well as the center and its tenants
- CC 13. General Plan Amendment No. 19-01 and Zone Change No. 19-02 Located at the Southeast Corner of 10th Street West and Avenue K-8 (Assessor's Parcel Number: 3128-004-016)

Recommendation:

Adopt **Ordinance No. 1084**, amending the zoning designation on 4.43 acres of land located on the southeast corner of 10th Street West and Avenue K-8 (Assessor's Parcel Number 3128-004-016), known as Zone Change No. 19-02, from Specific Plan (SP) to Commercial Planned Development (CPD).

The applicant is requesting to amend the General Plan land use designation from SP to C, and rezoning the subject site from SP to CPD, to allow the subject property to be developed with a commercial development. The GPA and ZC would be consistent with the goals, objectives and policies of the Lancaster General Plan 2030, because it is not incongruous with existing land-use patterns, or the character of the surrounding area. Therefore, staff is recommending approval to amend the General Plan land use designation from SP to C, and change the zoning designation from SP to CPD. On May 25, 2021, City Council approved the introduction of Ordinance No.1084 by the following vote: AYES: Dorris, Malhi, Mann, Crist NOES: None; ABSTAIN: None; ABSENT: Parris.

CC 14. Concert at Lancaster Municipal Stadium Funding Request

Recommendation:

a. Allocate \$88,000 from the general fund to account 101-4649-575 to cover costs associated with the Trace Adkins concert on June 27, 2021.

The event will be a great jumpstart to our special event season, provide for community engagement, and allow our community to return to the socialization they desire. The request for additional funding will cover the expenses associated with an event of this magnitude.

CC 15. Loan Agreement with Friends of the Antelope Valley Fair, Inc.

Recommendation:

- 1. Authorize the City Manager or his designee to negotiate and enter into a loan agreement with Friends of the Antelope Valley Fair, Inc. in the amount of \$250,000.00 for completion of the Antelope Valley Rural Museum.
- 2. Authorize the City Manager or his designee to finalize and execute all related documents.
- 3. Appropriate \$250,000.00 from Account No. 101-2900-000, Fund Balance to Account No. 101-1100-000, Accounts Receivable.

In the ensuing decade, members of AVRM and the Antelope Valley Fair worked to raise funds to establish a permanent home for the museum. Construction began in 2019 on a new facility at the Antelope Valley Fairgrounds, which will provide more than 10,000 square feet of exhibition space, a kitchen, and a small meeting space. The facility's shell is now complete. The proposed loan of \$250,000.00 would allow for accelerated completion of the museum's interior, thus, helping to make AVRM's extensive and growing collection accessible to the community as quickly as possible.

CC 16. Revenue and Expenditure Appropriations for Certain Conditioned Public Improvements Within and Around Various Residential Tracts from Proceeds of the Western Insurance Company Bond Claim

Recommendation:

Recognize revenue totaling \$2,413,423.82 in Western Insurance Company payments and increase appropriated expenditures and Capital Improvement Program (CIP) projects totaling \$2,400,000.00.

During the economic down-turn in 2007-2008, several tracts in the City were abandoned prior to completion and acceptance of grading and conditioned public improvements. In order to complete the improvements and/or make abandoned tracts safe, the City submitted claims on grading and improvement securities in accordance with the Undertaking Agreement for each tract. One such claim was to Western Insurance Company for fourteen (14) tracts in the amount of \$41,065,252.35. Subsequent to the economic down-turn, Western Insurance Company entered into liquidation. In a letter dated March 7, 2012, the City submitted Proof of Claim relative to the liquidation of Western Insurance Company as the obligee with respect to various grading permits, labor and materials and performance bonds issued by Western Insurance Company. In a letter dated March 4, 2014, the Liquidator of Western Insurance Company notified the City that \$9,180,293.96 of our claims for seven (7) tracts were approved, pending review and approval by the Court pursuant to Utah Code Annotated Section 31A-27a-608, and would be distributed on a pro-rata percentage of assets available for distribution. Subsequent to this notification, four (4) tracts were purchased, securities were substituted, and claims for those tracts were withdrawn. The approved amount was reduced to \$3,447,748.32 for the three (3) remaining tracts. The amount received, \$2,413,423.82, is a partial payment (70%) towards the approved amount of \$3,447,748.32.

Recommendations:

Fiscal Impact:

There is no fiscal impact to California Choice Energy Authority.

Background:

In October 2015, the State of California enacted Senate Bill 350, also known at the Clean Energy and Pollution Reduction Act of 2015 (the Act). The Act established new clean energy, clean air, and greenhouse gas reduction goals for the state. Specifically, the Act requires that all load serving entities, including Community Choice Aggregators (CCAs) enter into long-term renewable energy contracts with energy delivery to begin by the 2021 – 2024 compliance period (Compliance Period 4).

In order to meet this requirement, California Choice Energy Authority (CalChoice), on behalf of its member agencies has been seeking viable projects through solicitations and bilateral offers.

CalChoice and its legal and technical team spent several months negotiating and finalizing commercial and contract terms with Powerex Corporation (Powerex) on behalf of its member agencies. The energy delivered under this contract will be wind and biomass from the Pacific Northwest, and delivery will begin July 2021 for a period of ten years.

As a condition of the contract, payment terms are such that each member city's general fund is protected, and no additional credit or collateral is required by Baldwin Park Resident Utility District (BPROUD) and Pomona Choice energy (Pomona Choice) or CalChoice.

These agreements along with those already authorized and executed by CalChoice on behalf of the member cities, will fulfill BPROUD's and Pomona Choice's long term requirements for Compliance 4 as mandated by the Act.

Therefore, staff recommends that the Authority Board approve California Choice Energy Authority entering into a long-term renewable energy agreements substantially as attached with Powerex Corporation on behalf of Baldwin Park Resident Owned Utility District and Pomona Choice Energy.

Seller shall schedule or cause to be scheduled, at its sole discretion, Energy to the CAISO Balancing Authority on a day-ahead, hour-ahead, sub-hourly and/or real-time basis.

All Energy shall be scheduled in accordance with Generally Accepted Utility Practice.

E-tagging

Seller shall generate all e-Tags required to schedule the Energy to the Delivery Point and such e-Tags will be in accordance with generally accepted e-tagging practices and standards in the WECC region. For greater certainty, no e-Tags will be generated for Deliveries from a Project within the CAISO Balancing Authority. Each e-Tag will include the following, depending on the Category Product:

If a "sink" PSE is not specified above by Purchaser, Seller may, and Purchaser (for itself and Member) authorizes Seller to, use a sink PSE (including its own) consistent with generally accepted e-tagging practices and standards in the WECC region (including CAISO deliveries).

Tracking System:

WREGIS.

For Category 1 Product, WREGIS Certificates will be transferred following applicable WREGIS Timelines. For Category 2 Product, WREGIS Certificates will be transferred following the later of (i) applicable WREGIS Timelines and (ii) the month after delivery of associated Substitute Energy. WREGIS Certificates

will be transferred to Member's WREGIS account named [●] (WREGIS Account ID #[●]).

In the event WREGIS changes the WREGIS Operating Rules in effect on the Reference Date (or its application thereof) such that WREGIS Certificates cannot be transferred as required under this Confirmation, the Parties will negotiate in good faith using commercially reasonable efforts to revise or amend this Confirmation to the extent possible to enable the transfer of WREGIS Certificates as required hereunder.

Invoicing and Payment:

Excepted as provided below under "Payment in Equal Installments", invoicing and payment for Energy and Green Attributes Delivered hereunder shall be in accordance with Section 9 of the WSPP Agreement. The CAISO Credit will be reflected in the Energy invoice. The Parties acknowledge that invoicing and payments for the Energy may not occur in the same month as invoicing and payments for the Green Attributes associated with such Energy. Seller shall be entitled to retain for its account all revenues received from the CAISO associated with the delivery of Energy to the CAISO Balancing Authority.

Payment in Equal Installments

Purchaser shall pay in equal monthly installments as follows:

- (a) For each Generation Sub-term, Purchaser shall pay for the total contracted quantity for such Generation Sub-term (i.e., the minimum quantity specified for such Generation Sub-term in the table under "Energy Delivery Profile") in advance in equal monthly installments across all months within such Generation Sub-term.
- (b) Seller will issue an invoice for each monthly installment. For each Generation Sub-term, the first invoice will be issued the month prior to the start of the Generation Sub-term and then monthly thereafter, with the last such invoice issued in the second-to-last (penultimate) month of the Generation Sub-term.
- (c) In the event deliveries in any Generation Sub-term are subject to a minimum and maximum (*i.e.*, minimum quantity and maximum quantity specified in the table under "Energy Delivery Profile"), the equal monthly installments shall be based on the minimum delivery obligation. Any quantity over and above the minimum quantity (up to the maximum quantity) will be invoiced and paid in accordance with Section 9 of the WSPP Agreement, provided Seller will not issue the invoice for any such additional quantity prior to Delivery of the minimum quantity.
- (d) For greater certainty, if there is more than one Generation Sub-term the equal monthly installments may vary between Generation Sub-terms depending on the applicable Contract Price, contracted quantity and number of months.
- (e) To the extent at any time payments to Seller exceed deliveries to Purchaser with respect to any Generation Sub-term, Purchaser shall not have any right to request a return of any excess payment, and any excess payment will be held by Seller as collateral/performance assurance and applied

automatically to future deliveries in the applicable Generation Sub-term provided that if any such excess payment remains after full settlement for all deliveries hereunder during the Generation Term then such excess hereunder will be credited to Purchaser in the final invoice for deliveries hereunder. [NTD: If there was excess after full settlement, the last invoice would show a refund to CCEA for this transaction – if multiple transactions, that amount would net against payments owing for other transactions]

(f) For greater certainty, payment in equal installments does not restrict or fetter Seller's discretion to schedule and deliver the Product hereunder.

Seller's invoices may be delivered by email from Seller to Purchaser.

Change in Law:

Regulatorily Continuing, provided that Seller's obligations to make reasonable efforts or commercially reasonable efforts to obtain compliance with a Change in Law (or "change in law") shall not require Seller to incur any costs and expenses related thereto or suffer any losses in connection therewith, whether direct or indirect, in excess of the limits set forth in Section 10 of the Special Conditions. Subject to the above noted agreed maximum amount, provided that Seller is making reasonable efforts or commercially reasonable efforts, as applicable, to obtain compliance with any Change in Law (or change in law), any non-compliance shall not be an Event of Default and, to the extent such Change in Law (or change in law) results in a Failing Category Product hereunder, Section 2 of the Special Conditions shall apply and be the exclusive remedy of the Parties (and all other damages or remedies are waived).

SPECIAL CONDITIONS

- 1. <u>Additional Definitions and Modifications</u>. The defined terms set forth in Schedule "B" and the amendments and modifications to the WSPP Agreement and Service Schedule R set forth in Schedule "C" shall apply to this Confirmation.
- 2. <u>Eligibility Requirements</u>. If, at any time, a Category Product does not meet the applicable Eligibility Requirements (a "Failing Category Product"), it shall not be an Event of Default for the purposes of the WSPP Agreement. If a Failing Category Product does not meet or satisfy the Eligibility Requirements for any reason other than a Purchaser Eligibility Failure, a Seller Eligibility Failure or Uncontrollable Force, the following shall apply:
 - (a) the Parties will negotiate in good faith using commercially reasonable efforts to revise or amend this Confirmation as appropriate so that the Failing Category Product meets or satisfies the applicable Eligibility Requirements in a manner consistent with the intent of the Parties as set out in this Confirmation.
 - (b) If the Parties are unsuccessful in revising or amending the Confirmation as provided in (a) above:
 - (i) the Parties will have no liability to each other for any failure to schedule, Deliver or Accept the Failing Category Product that is not then Delivered (provided, for greater certainty, that Purchaser shall remain liable for any Green Attributes associated with Energy already Delivered); and
 - (ii) either Party may, by written notice to the other, immediately terminate the Transaction and this Confirmation, without penalty, termination payment or liability of either Party to the other except as provided in sub-paragraph (i) above.

- 3. Failure to Deliver/Accept. Notwithstanding the Contract Price being expressed as the sum of the Energy Price (less CAISO Credit) and the applicable GA Price, the calculation of damages for failure to Deliver or Accept the Product (or any component thereof) shall be calculated in accordance with Section R-9.1.2(a), subject to the modifications set forth herein. For greater certainty: (i) any quantity of Category Product that does not meet or satisfy the applicable Eligibility Requirements as a result of a Seller Eligibility Failure shall be considered a failure to Deliver by Seller, and (ii) Seller shall not be liable to Purchaser for any quantity of Category Product that does not meet or satisfy the applicable Eligibility Requirements as a result of a Purchaser Eligibility Failure. If WREGIS Certificate(s) are not transferred as required by this Confirmation solely as a result of an error or omission of WREGIS or the CAISO, it shall not be a failure to Deliver or Accept, however the Parties shall use commercially reasonable effort and cooperate in good faith to cause WREGIS to correct its error or omission to complete such transfer.
- 4. Waived Shortfall Category 2 Product. If Seller reasonably anticipates that it will be unable to Deliver the required quantity of Category 2 Product with respect to any Generation Sub-term or the Generation Term, Seller may provide written notice to Purchaser on or before sixty (60) days prior to the end of the applicable Generation Sub-term and, upon Purchaser's receipt of such notice, the Parties will negotiate in good faith using commercially reasonable efforts to determine whether Seller may deliver a product comparable in all material respects to the Category 2 Product generated by or attributable to an Alternate Eligible Facility or Alternate Source ("Alternate Supply"). If the Parties mutually agree to such arrangements for Alternate Supply, they will enter into a separate agreement respecting same (which will include the same Contract Price and otherwise be in substantially the same form as this Confirmation) and Purchaser will waive the shortfall and any related liquidated damages that may otherwise be payable pursuant to this Confirmation for the amount of such Alternate Supply.
- 5. <u>Events of Default; Remedies</u>. For purposes of this Transaction:
 - (a) For the purposes of determining payments under Section 22 of the WSPP Agreement, with respect to this Transaction, the economic benefits or losses of the Non-Defaulting Party resulting from termination of this Transaction shall be based on the energy and Green Attributes components of the Product.
 - (b) The remedies for failure to Deliver or Accept the Product (including Green Attributes) provided for in the WSPP Agreement and Service Schedule R, as amended by this Confirmation, are the sole and exclusive remedies and all other remedies are waived.
- 6. <u>Importer of Energy/Compliance Obligation</u>. For any Energy imported into California, Seller will be the electricity importer into California for purposes of the Cap and Trade Regulations. The Parties acknowledge that Seller will be responsible for satisfying the Compliance Obligation under the Cap and Trade Regulations associated with the energy which Seller shall schedule and import into the CAISO Balancing Authority as part of the Product to be delivered under this Confirmation and that Seller may and shall have the right to claim that any Energy that Seller has scheduled and imported into the CAISO Balancing Authority is from a Specified Source and claim the RPS Adjustment with respect to Substitute Energy. Purchaser agrees to assist Seller in making the Specified Source and RPS Adjustment claims, including agreeing as follows:
 - (a) Specified Source Category 1 Product. [Reserved].
 - (b) RPS Adjustment Category 2 Product. Purchaser agrees to provide Seller with the information required by Seller for the purpose of claiming the RPS Adjustment including, but not limited to, providing by May 15 following the end of each calendar year in the Generation Term a written attestation to Seller that the quantity of WREGIS Certificates transferred under this Confirmation associated with the immediately previous calendar year in the Generation Term as Category 2 Product have been placed in Purchaser's or

Member's WREGIS retirement subaccount and that the RECs represented by such WREGIS Certificates have been designated for retirement for the purposes of Purchaser's or Member's compliance with the RPS for the applicable year in the Generation Term in accordance with the Cap and Trade Regulation (and shall promptly notify Seller of any changes (e.g. subsequent withdrawal of WREGIS Certificates from Purchaser's or Member's WREGIS retirement subaccount) after delivery of the attestation with information as may be required by Seller to comply with Section 95111.g.1.M.2 of the Mandatory Reporting Rule (or any similar or successor provision)).

- (i) In the event Purchaser or Member re-sells Category 2 Product, Purchaser shall continue to provide the attestation provided in this Section 6(b) and references to "Purchaser's or Member's WREGIS retirement subaccount" and "Purchaser's or Member's compliance with the RPS" shall be read to include the subsequent purchaser's WREGIS retirement subaccount and compliance with the RPS.
- (ii) If Seller does not meet the conditions for the RPS Adjustment as a result of any act or omission of Purchaser or Member (including any resale or breach of Section 8 of these Special Conditions by Member) or CARB, a verification body or court of competent jurisdiction does not consider Member to be a party hereto for the purposes of Section 95852(b)(4) of the Cap and Trade Regulations, Purchaser shall reimburse or pay Seller the cost of Allowances (as defined in Cap and Trade Regulation 95802(a)(8)) purchased or required by Seller as a result of Seller's inability to claim the RPS Adjustment, at the price established at the next succeeding auction of Allowances hosted by CARB or, failing which, prevailing market prices.

Notwithstanding Section 8 of these Special Conditions, Purchaser remains primarily liable to Seller for Purchaser's obligations under this Section 6.

This Section 6 is based on the Cap and Trade Regulations and Mandatory Reporting Rule as of the Reference Date of this Confirmation. In the event that the regulatory requirements for mitigating the Compliance Obligation change after the Reference Date, Purchaser shall make commercially reasonable efforts to assist Seller in meeting such regulatory requirements. This provision shall survive expiry or earlier termination of this Transaction until such time as the information contemplated herein in respect of the last year of the Generation Term is provided to Seller by Purchaser.

7. Standard/Non-Modifiable Terms and Conditions.

- (a) This Agreement and the rights and duties of the Parties hereunder shall be governed by and construed, enforced and performed in accordance with the laws of the state of California, without regard to principles of conflicts of law. To the extent enforceable at such time, each Party waives its respective right to any jury trial with respect to any litigation arising under or in connection with this Agreement. [STC 17]
- (b) Seller shall be responsible for ensuring that: (i) each Project is certified as an eligible renewable energy resource for the RPS prior to delivery of Category 1 Product or Category 2 Product hereunder from such Project; and (ii) the Green Attributes have been or will be transferred to Seller and will be transferrable to Member through or using WREGIS, or such similar generation information or attributes tracking system as may be approved by or other method of transfer acceptable to the Energy Commission;
- (c) Seller warrants that all necessary steps to allow the Renewable Energy Credits transferred to Buyer to be tracked in the Western Renewable Energy Generation Information System will be taken prior to the first delivery under the contract [STC REC-2];

- (d) Seller hereby provides and conveys all Green Attributes associated with all electricity generation from the Project as part of the Product being delivered. Seller represents and warrants that Seller holds the rights to all Green Attributes from the Project, and Seller agrees to convey and hereby conveys all such Green Attributes as included in the delivery of the Product from the Project; and
- (e) For the purposes of this Transaction:
 - (i) Seller, and, if applicable, its successors, represents and warrants that throughout the Delivery Term of this Agreement that: (i) the Project qualifies and is certified by the CEC as an Eligible Renewable Energy Resource ("ERR") as such term is defined in Public Utilities Code Section 399.12 or Section 399.16; and (ii) the Project's output delivered to Buyer qualifies under the requirements of the California Renewables Portfolio Standard. To the extent a change in law occurs after execution of this Agreement that causes this representation and warranty to be materially false or misleading, it shall not be an Event of Default if Seller has used commercially reasonable efforts to comply with such change in law [STC 6]; and
 - (ii) Seller and, if applicable, its successors, represents and warrants that throughout the Delivery Term of this Agreement the Renewable Energy Credits transferred to Buyer conform to the definition and attributes required for compliance with the California Renewables Portfolio Standard, as set forth in California Public Utilities Commission Decision 08-08-028, and as may be modified by subsequent decision of the California Public Utilities Commission or by subsequent legislation. To the extent a change in law occurs after execution of this Agreement that causes this representation and warranty to be materially false or misleading, it shall not be an Event of Default if Seller has used commercially reasonable efforts to comply with such change in law. [STC REC-1]

For the purposes of STC 6 above, for the Category 2 Product, the Parties acknowledge that Seller is delivering Substitute Energy, in substitution for Project Energy, and Green Attributes.

As used in Section 7(e) of these Special Conditions, "Delivery Term" has the same meaning as "Generation Term" provided that, for the purposes of STC 6 above with respect to any facility listed in Schedule A, the Parties agree that the representation and warranty therein applies only to the portion of such Delivery Term that is after the eligibility date issued by the CEC and during which the output from that facility is being delivered pursuant to this Confirmation.

- 8. <u>Member Obligations</u>. Member hereby agrees to take (or cause to be taken) the following actions:
 - (a) For Category 1 Product, to place the WREGIS Certificates in its WREGIS retirement subaccount or WREGIS active subaccount for the purposes of its compliance with the RPS;
 - (b) For Category 2 Product, to place the WREGIS Certificates in its WREGIS retirement subaccount and designate the RECs represented by such WREGIS Certificates for retirement for the purposes of its compliance with the RPS for the applicable year in the Generation Term in accordance with the Cap and Trade Regulation; and
 - (c) To provide Seller with written attestations as set forth in Section 6 of these Special Conditions within the time required by such Section.

Member is not a party to the WSPP Agreement, but hereby agrees to incorporation and application of such terms to the extent required to enforce this Section 8, provided that the application of the WSPP Agreement is expressly subject to the modifications in this Confirmation.

9. <u>Resale</u>. Seller makes no representation or warranty that the Category 1 Product or Category 2 Product will satisfy applicable Eligibility Requirements if re-sold by Purchaser. In the event all or any portion of the Category Product(s) purchased or to be purchased by Purchaser hereunder is resold by Purchaser, any such resale does not affect Purchaser's obligations hereunder and Purchaser remains primarily liable to Seller for all Purchaser's obligations hereunder.

10. Commercially Reasonable Efforts.

- (a) A Party required to use or make "reasonable efforts" or "commercially reasonable efforts" pursuant to this Confirmation shall not be required to incur more than \$25,000 in aggregate direct or indirect costs, including lost profits, and out-of-pocket costs and expenses, to comply with such "commercially reasonable efforts", and then only to the extent incurring such costs would be reasonably likely to achieve the desired effect.
- (b) In the event an issue or circumstance requiring a Party to use or make reasonable efforts or commercially reasonable efforts similarly affects one or more other transactions between the Parties, the limit set forth in paragraph (a) above shall not be cumulative to any limits applicable to such other transactions.
- 11. Supporting Data. For the applicable Category Product delivered from facilities outside CAISO Balancing Authority Area, Seller will provide Purchaser with hourly meter data, e-Tag data and, if applicable, associated calculations of the lesser of each by hour for each month RECs are delivered to Purchaser under this Confirmation. Further, Seller will use commercially reasonable efforts to provide such other data or information as may be reasonably requested and required by Purchaser for the purposes of using the applicable Category Product for its compliance with the RPS provided such requested data or information is available to Seller and can be disclosed by Seller to Purchaser without breaching confidentiality obligations owed to a third party.
- 12. <u>Confidentiality</u>. Section 30.1 of the WSPP Agreement is amended by deleting the "or" immediately before subsection (7) and inserting the following immediately after the end of subsection (7) "or, (8) to Deliver RECs pursuant to the requirements of the Tracking System".
- 13. <u>Entire Agreement</u>. This Confirmation sets forth the terms of the Transaction into which the Parties have entered and shall constitute the entire agreement between the Parties relating to the contemplated purchase and sale of the Product.
- 14. <u>Condition Precedent</u>. This Confirmation (and the Transaction confirmed thereby) shall not be binding upon any Party until and unless both Powerex and CCEA have executed and delivered this Confirmation to the other Party before 5:00 p.m. Pacific Prevailing Time on [•], 2021. If either Party fails to satisfy the foregoing condition precedent, then this Confirmation (and the Transaction confirmed thereby) shall have no force and effect and all offers hereunder shall be deemed rescinded.

- (c) "Alternate Eligible Facility" means an alternate generation facility that is certified as an eligible renewable energy resource for the RPS and from which Seller is entitled to energy and associated Green Attributes generated during the Generation Term (or portion thereof in respect of which bundled energy and associated Green Attributes to be Delivered hereunder are generated by such facility).
- (d) "<u>Alternate Source</u>" means an alternate source of supply of energy and associated Green Attributes generated by the same facility as a Project during the Generation Term and which Seller is entitled to pursuant to its purchase agreements for output from the facility.
- (e) "Buyer" means Purchaser.
- (f) "CAISO Balancing Authority" means, as the context requires, CAISO as "Balancing Authority" or "CAISO Balancing Authority Area", as such terms are used in the CAISO Tariff.

- (k) "Category 1 Product Eligibility Requirements" means, with respect to the Category 1 Product only, any applicable criteria or requirements of the RPS in force and effect as of the Reference Date regarding the eligibility or qualification of the Category 1 Product to meet the criteria of Section 399.16(b)(1) of the California Public Utilities Code or this Confirmation or the Transaction confirmed hereby for the RPS, including without limitation any eligibility criteria applicable to an out-of-state resource.
- (l) "Category 2 Product" means the Product where Purchaser has elected to have Substitute Energy Delivered in substitution for Project Energy in accordance with Delivery Method 2.
- (m) "Category 2 Product Eligibility Requirements" means, with respect to Category 2 Product only, any applicable criteria or requirements of the RPS in force and effect as of the Reference Date regarding the eligibility or qualification of the Category 2 Product to meet the criteria of Section 399.16(b)(2) of the California Public Utilities Code or this Confirmation or the Transaction

confirmed hereby for the RPS, including without limitation any eligibility criteria applicable to an out-of-state resource.

- (n) "Category Product" means Category 1 Product or Category 2 Product, as applicable.
- (o) "change in law" means "Change in Law" as defined in Service Schedule R, as modified herein.
- (p) "Compliance Obligation" has the meaning set forth by the Cap and Trade Regulations.
- (q) "CPUC" means the California Public Utilities Commission.
- (r) "<u>Effective Date</u>" means the date on which both Parties have executed and delivered this Confirmation.
- (s) "<u>Eligibility Requirements</u>" means Category 1 Product Eligibility Requirements or Category 2 Product Eligibility Requirements, as applicable.
- (t) "Energy" means Project Energy or Substitute Energy, as applicable.
- (u) "Energy Commission" or "CEC" means the California Energy Commission.
- (v) "Environmental Attributes" means Green Attributes.
- (w) "Generally Accepted Utility Practice" means a practice established by the Western Electricity Coordinating Council ("WECC") or any successor regional reliability council, as such practice may be revised from time to time, or if no practice is so established, means a practice otherwise generally accepted in the WECC region.
- (x) "<u>Generation Sub-term</u>" means any sub-period within the Generation Term as specified in the Energy Delivery Profile Table under the heading "Delivery Method Quantity" (and for greater certainty means Generation Term if only one Generation Sub-term).
- "Green Attributes" means any and all credits, benefits, emissions reductions, offsets, and (y) allowances, howsoever entitled, attributable to the generation from the Project, and its avoided emission of pollutants. Green Attributes include but are not limited to Renewable Energy Credits, as well as: (1) any avoided emission of pollutants to the air, soil or water such as sulfur oxides (SOx), nitrogen oxides (NOx), carbon monoxide (CO) and other pollutants; (2) any avoided emissions of carbon dioxide (CO2), methane (CH4), nitrous oxide, hydrofluorocarbons, perfluorocarbons, sulfur hexafluoride and other greenhouse gases (GHGs) that have been determined by the United Nations Intergovernmental Panel on Climate Change, or otherwise by law, to contribute to the actual or potential threat of altering the Earth's climate by trapping heat in the atmosphere; (3) the reporting rights to these avoided emissions, such as Green Tag Reporting Rights. Green Tag Reporting Rights are the right of a Green Tag Purchaser to report the ownership of accumulated Green Tags in compliance with federal or state law, if applicable, and to a federal or state agency or any other party at the Green Tag Purchaser's discretion, and include without limitation those Green Tag Reporting Rights accruing under Section 1605(b) of The Energy Policy Act of 1992 and any present or future federal, state, or local law, regulation or bill, and international or foreign emissions trading program. Green Tags are accumulated on a MWh basis and one Green Tag represents the Green Attributes associated with one (1) MWh of Energy. Green Attributes do not include (i) any energy, capacity, reliability or other power attributes from the Project, (ii)

¹ Avoided emissions may or may not have any value for GHG compliance purposes. Although avoided emissions are included in the list of Green Attributes, this inclusion does not create any right to use those avoided emissions to comply with any GHG regulatory program.

production tax credits associated with the construction or operation of the Project and other financial incentives in the form of credits, reductions, or allowances associated with the project that are applicable to a state or federal income taxation obligation, (iii) fuel-related subsidies or "tipping fees" that may be paid to Seller to accept certain fuels, or local subsidies received by the generator for the destruction of particular preexisting pollutants or the promotion of local environmental benefits, or (iv) emission reduction credits encumbered or used by the Project for compliance with local, state, or federal operating and/or air quality permits. If the Project is a biomass or biogas facility and Seller receives any tradable Green Attributes based on the greenhouse gas reduction benefits or other emission offsets attributed to its fuel usage, it shall provide Buyer with sufficient Green Attributes to ensure that there are zero net emissions associated with the production of electricity from the Project.

- (z) "Green Tag Purchaser", as used in the definition of Green Attributes, means Purchaser or Member, as applicable.
- (aa) "Mandatory Reporting Rule" means the regulations entitled Mandatory Greenhouse Gas Emissions Reporting set forth at Article 2 of Subchapter 10 of Title 17 of the California Code of Regulations.
- (bb) "Party" means Purchaser or Seller, and "Parties" means both Purchaser and Seller. Member is a Party to this Confirmation for the purposes of Section 8 of the Special Conditions.
- (cc) "<u>Permitted Encumbrances</u>" means any liens, claims, security interests or other encumbrances arising or attaching upon or after transfer of title or through Purchaser or Member.
- (dd) "Project" means a facility listed in Schedule "A" provided that, for the purposes of Section 7(d) of the Special Conditions, the term "Project" shall be read to refer to all such facilities listed in Schedule "A" but only to the extent of Seller's contractual rights to the energy and Green Attributes produced by such facilities. Seller must be contractually entitled to all or a portion of the bundled energy and associated Green Attributes generated by the facilities listed in Schedule "A" during the Generation Term (or portion thereof in which the Product is generated by or attributed to such facility). Purchaser acknowledges that Seller (i) may deliver the Product from any or all Projects, and (ii) may not have a contractual right to the entire output of such facilities.
- (ee) "Purchaser Eligibility Failure" means a failure of a Category Product to meet or satisfy the applicable Eligibility Requirements or any element or component thereof which are in the direct control of Purchaser or Member to meet or satisfy as a result of or if caused by or attributable to an act or omission of Purchaser or Member, including use of the Product other than for its own RPS compliance purposes, procurement by Purchaser on behalf of Member rather than on its own behalf, a failure by Purchaser or Member to accept an applicable transfer on WREGIS, to provide information and data available to Purchaser or Member (including as provided by Seller) as may be required to verify the Green Attributes comprised in the Products or failure to retire or designate for retirement the RECs for the purposes of compliance with the RPS.
- (ff) "REC" or "Renewable Energy Credit" means "renewable energy credit" as set forth in California Public Utilities Code Section 399.12(h).
- (gg) "Reference Date" means the date that Powerex has executed this Confirmation (as reflected on the signature page hereto.
- (hh) "<u>RPS</u>" means the California Renewables Portfolio Standard Program codified at California Public Utilities Code Section 399.11 *et seq*.
- (ii) "<u>RPS Adjustment</u>" means the reduction in the Compliance Obligation of an electricity importer authorized by and calculated in accordance with section 95852 (b)(4) of the Cap and Trade Regulations and section 95111(b)(5) of the Mandatory Reporting Rule.

- (jj) "RPS ID" means the "California Energy Commission RPS certification number", the "identification number" and/or the "RPS ID", as such terms are used by the CEC to describe the identification number for an eligible renewable energy resource that has been certified (or will be certified for the period of deliveries) as such by the CEC for the purposes of the RPS. The RPS ID for each Project is set out beside the applicable facility under the column "RPS ID" in the table attached hereto as Schedule "A".
- (kk) "Scheduling Point" has the meaning set forth in the CAISO Tariff, including (without limitation) the SYLMARDC 2 N501 and MALIN 5 N101 Scheduling Points.
- (II) "Seller Eligibility Failure" means a failure of Category 1 Product or Category 2 Product to meet or satisfy the applicable Eligibility Requirements or element or component thereof applicable to a Category Product which are in the direct control of Seller to meet or satisfy as a result of or if caused or attributable to an act or omission by Seller, unless such failure is excused by Uncontrollable Force.
- (mm) "Special Conditions" means the terms and conditions identified under the heading "Special Conditions" of this Confirmation.
- (nn) "Specified Source" means "specified source", as such term is defined in the Mandatory Reporting Rule.
- (00) "WREGIS" means the Western Renewable Energy Generation Information System or any successor renewable energy tracking program.
- (pp) "<u>WREGIS Certificate</u>" means a "Certificate" as defined by WREGIS in the WREGIS Operating Rules and designated by law as eligible for complying with the RPS and for evidencing the Green Attributes associated with the Product.
- (qq) "WREGIS Operating Rules" means the operating rules and requirement adopted by WREGIS, as amended from time to time.
- (rr) "WREGIS Timelines" means the time line for WREGIS Certificate creation by WREGIS in accordance with WREGIS Operating Rules as applied by WREGIS.

17 SCHEDULE "C"

Amendments and Modifications to WSPP Agreement and Service Schedule R

The Parties agree to the following applications of the WSPP Agreement and the following conditions shall apply to this Transaction.

- 1. <u>Clarification Regarding "All Attributes"</u>. The following is inserted after the word "producing" on the fourth line of Section R-2.4.1 of Service Schedule R: "associated with the REC to be transferred".
- 2. <u>Clarification Regarding Delivery of RECs.</u> The following is deleted from the first sentence of Section R-3.1.1: "the Contract Quantity to Purchaser" and replaced with "a REC to Purchaser in accordance with this Agreement or as otherwise provided in a Confirmation".
- 3. <u>Clarification Regarding Acceptance of RECs</u>. The following is added to the end of Section R-3.1.2 of Service Schedule R: "Purchaser shall not be entitled to reject or refuse to Accept any RECs Delivered which comply with the requirements of a Confirmation pursuant to which they are Delivered. Purchaser's rejection of or failure to Accept any conforming RECs Delivered in accordance with this Agreement and the applicable Confirmation shall be subject to Section R-9.1.1 or R-9.1.2 of Service Schedule R, as the case may be, as modified by a Confirmation."
- 4. <u>Clarification Regarding Delivery in Bundled REC Transactions</u>. The following is deleted from the first sentence of Section R-3.2.1: "the Contract Quantity of the REC and the Contract Quantity of the Energy" and replaced with "the REC and the Energy in accordance with this Agreement or as otherwise provided in a Confirmation".
- 5. <u>Passage of Title of RECs in Bundled REC Transactions</u>. The second sentence of Section R-3.2.3 of Service Schedule R is deleted and replaced with the following: "If the REC is to be generated on or after the Effective Date, title to the REC shall pass from Seller to Purchaser (on behalf of Member) upon Delivery and Acceptance."
- 6. <u>Generation Information and Expedited Certificates</u>. The first sentence of Section R-3.3.1 of Service Schedule R is deleted. The Parties acknowledge and confirm that this Confirmation does not provide for forward transfer certificates in WREGIS or for any other designated Tracking System to expedite transfer of certificates.
- 7. <u>Clarification Regarding Issuance of RECs</u>. The first sentence of Section R-3.3.2 is deleted up to the semicolon and replaced with the following: "Seller is responsible for ensuring the transfer and issuance of RECs by the Tracking System;".
- 8. <u>Clarification Regarding Conveyance</u>. The words "As of both Delivery and" are deleted from the first line of Section R-3.4 of Service Schedule R and replaced with "Upon".
- 9. <u>Definition of "Change in Law"</u>. The first sentence of Section R-5.2.2(a) is deleted and replaced with the following: "(a) "Change in Law" means any addition, amendment, decision, ruling, order, binding interpretation, determination, guideline, policy or guidance by or of a Governmental Authority, to or regarding any laws, rules, regulations, orders, or judicial precedent, that applies to an Applicable Program designated in the Confirmation, that is enacted, issued or becomes effective after the Reference Date and materially affects the Applicable Program or compliance of the REC with the Applicable Program."
- 10. <u>Title Representation</u>. The words "As of both Delivery and" are deleted from the first line of Section R-6.1 of Service Schedule R and replaced with "Upon". The following is added at the end of the last sentence of Section R-6.1: "other than Permitted Encumbrances."

- 11. Other Programs. The following is added after the last sentence of Section R-6.3: "Except as expressly set forth herein regarding the Applicable Program, Seller makes no representation or warranty that the Product will meet any particular requirement or will have any particular use or value or will be eligible for any particular renewable portfolio standard, green pricing program or governmental or voluntary compliance program or will offset, avoid, reduce or obtain credit for any reduction of pollutants or air emissions created by Purchaser's or any other person's electric generating facilities or any other facilities (each, an "Alternative Program"), and Seller shall have no obligations to Purchaser with respect to any such Alternative Programs."
- 12. <u>Information Disclosed.</u> The end of the last sentence of Section R-7.2 is deleted after the word "Confirmation."
- 13. Uncontrollable Force. For purposes of this Transaction, the performance of the Parties' obligations under the WSPP Agreement and this Confirmation shall be subject to Uncontrollable Force and Section 10 of the WSPP Agreement shall apply such that either Party will be relieved of its obligations to sell and Deliver or purchase and Accept the Product without liability to the extent that, and for the period during which such performance is prevented by Uncontrollable Force. The following is added at the end of subparagraph (ii) of Section 10 of the WSPP Agreement as set out in Section R-8: ", except to the extent such supply is itself subject to Uncontrollable Force." The following is added to the sixth line of the addition to the second paragraph of Section 10 of the WSPP Agreement as set out in Section R-8 after the words "Schedules B and C": "or similar products which are not of an as-run nature". In the event of any dispute regarding Seller's allocation of production during a period of curtailment, all information relating to such allocation and Seller's compliance with Section R-8 shall be provided to a qualified independent third party selected by Seller for review and determination and shall not be provided directly to Purchaser. Purchaser shall be entitled to receive a written copy of such independent third party's determination provided that no confidential or commercially sensitive information of Seller or third parties is disclosed therein or has been redacted therefrom.
- 14. <u>Failure to Accept or Deliver in Bundled REC Transactions</u>. The last sentence of the modification to Section 21.3(a)(1) of the WSPP Agreement as set forth in Section R-9.1.2(a) is deleted. The text falling after the words "achieve such reduction)" in the modification to Section 21.3(a)(2) of the WSPP Agreement as set forth in Section R-9.1.2(a) is deleted.
- 15. <u>Replacement Price and Resale Price</u>. "Energy" is deleted from the eighth line of Section R-10.1.4 and from the sixth line of Section R-10.1.5 and replaced with "the Product (or such component thereof)".

Background:

The proposed project is funded by the State of California, Department of Transportation (Caltrans) Highway Safety Improvements Program (HSIP) and local matching funds, including gas tax funds, TDA Article 3 funds, TDA Article 8 funds, Proposition C funds, Measure R funds, and Traffic Impact fees. 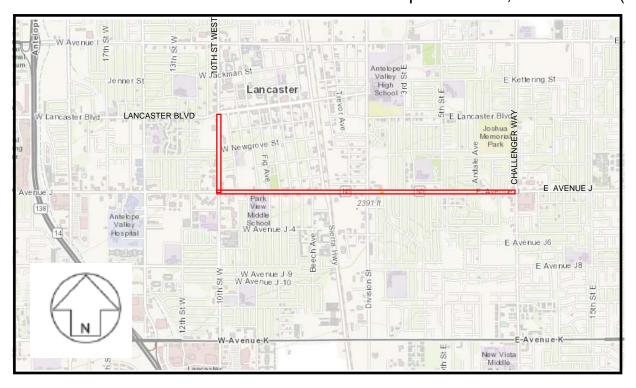

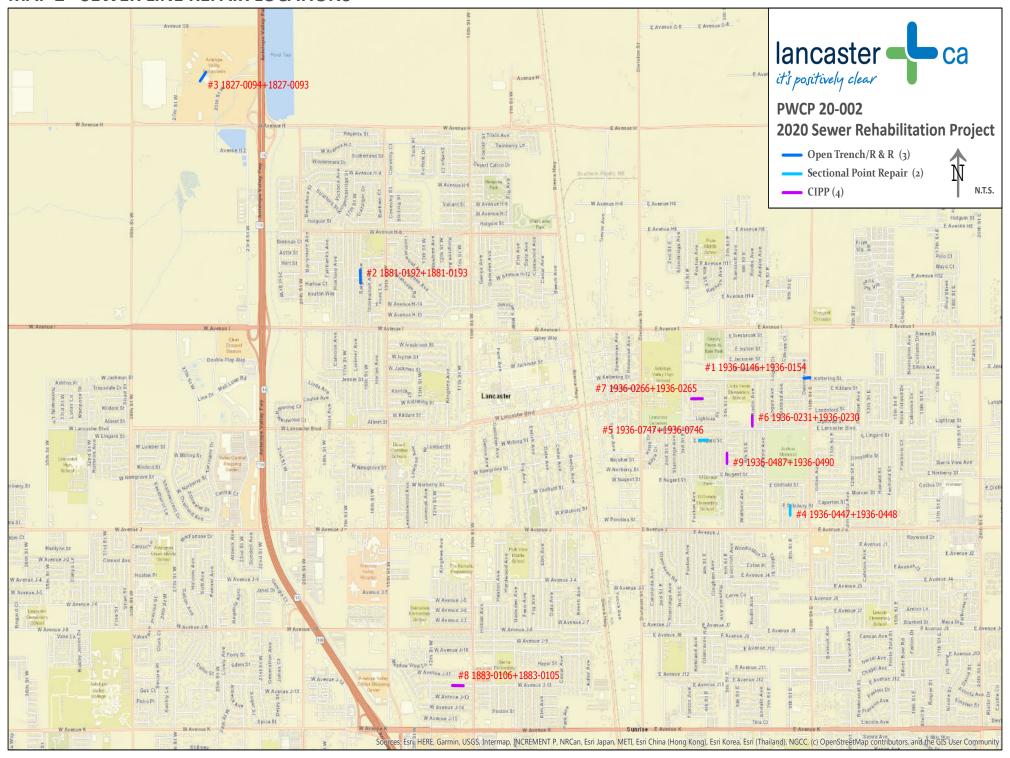

Recommendation:

Accept the work constructed by DOD Construction, for PWCP 20-003, 2019 Sidewalk, Curb and Gutter Repairs, and direct the City Clerk to file the Notice of Completion for the project. Retention on this project will be disbursed in accordance with the California Public Contract Code.

Fiscal Impact:

\$1,904,448.15 (including 10% contingency) was awarded based on the original contract. There was one (1) change order totaling (\$13,452.50), having brought the contract cost to \$1,717,864.00. Sufficient funds were available in Capital Improvements Budget Account Numbers 211-12ST044-924 and 701-12ST044-924. There are no associated annual maintenance costs.

Background:

In 2017, the City of Lancaster launched the Summer of Sidewalks program aimed to alleviate some of the backlog of concrete repair projects needed throughout the City. As part of the project, the City was able to repair or replace 25,000 square-feet (SF) of sidewalk and one-hundred (100) curb and gutter locations. The project also included root pruning thirty-two (32) trees to improve the trees longevity, and to prevent future damage to nearby sidewalks, gutter and asphalt, as well as upgrading seventy-eight (78) curb ramps to improve ADA access. The overall success of the project led to the creation of an annual concrete repair program to address future concrete improvements needed throughout the City.

In May 2019, the City of Lancaster adopted Resolution No. 19-17 to move forward with the issuance of revenue bonds, series 2019 (Measure M and Measure R Street Improvement Projects), to accelerate the completion of major road improvement projects located throughout the City's urban core. In October 2019, the City executed a Bond Purchase Agreement with the bond proceeds being allocated to multiple road improvement projects that will go to construction over

the next three (3) years. The 2019 Sidewalk, Curb and Gutter Repairs project was part of the first phase of bond funded road improvement projects, and repaired, replaced or constructed 12,321 SF of concrete, repaired 3,073 linear-feet (LF) of curb and gutter, and 3,567 SF of cross gutters and spandrels. The project also included trimming twenty (20) trees. This helped improve the health of the trees and improve the overall appearance. In addition, the City improved ninety (90) curb ramps in compliance with the City of Lancaster's 2014 ADA Transition Plan.

Per Section 2.2, this project was subject to the Community Workforce Agreement by and between the City of Lancaster and Los Angeles/Orange Counties Building and Construction Trades Council and the Signatory Craft Councils and Unions ("CWA"). The PWCP 20-003 contract documents were prepared, and the project was advertised accordingly. Per Section 2.6(b) of the CWA, Letters of Assent were submitted by the Contractor and each of its subcontractors, of whatever tier, forty-eight (48) hours prior to commencement of work, or within forty-eight (48) hours after the award of Project Work to that Contractor (or subcontractor), whichever occurs later.

The project included, but was not limited to, full depth pavement reconstruction with Cement Treated Base (CTB), installation of thickened edge of pavement, shoulder grading, manhole adjustment and striping.

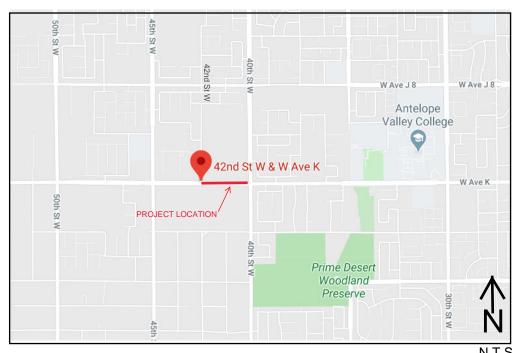

Recommendation:

Adopt **Resolution No. 21-26**, approving Senate Bill 1 (SB 1) Proposed Project List Form and allocate funds in the fiscal year 2021-2022 Capital Improvement Budget to clarify Road Maintenance and Rehabilitation Account (RMRA) funded projects.

Fiscal Impact:

None.

Background:

The Road Repair and Accountability Act of 2017, Senate Bill 1 (SB 1), was passed by the State Legislature and signed into law by the Governor in April 2017. The purpose of the bill is to help the state and local agencies address road maintenance. SB 1 will generate revenue through increases in gas tax, vehicle registration fees, and fees on zero emission vehicles. The tax and fee rate increases are implemented over time, beginning on November 1, 2017, with final implementation of all of the rate and fee increases in July 2020. Therefore, SB 1 was designed to adjust the tax and fee rates based on annual changes in the California Consumer Price Index (CPI).

SB 1 emphasizes the importance of accountability and transparency, therefore, in order to be eligible for RMRA funding, statue requires cities adopt a proposed project list at a regular public meeting. The list of proposed projects must include a description and location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement. Cities must also adopt RMRA funded projects into a city's operating or capital improvement budget. Cities must then submit the completed SB 1 Proposed Project List form to the California Transportation Commission (CATC), in order to receive its apportionment of RMRA funds from the State Controller.

Staff recommends the inclusion of the 10th Street West and Avenue J Improvements (PWCP 19-002), Lancaster Health District, formerly Medical Main Street (PWCP 20-006), and

2021 Summer Pavement Management Program (PWCP 21-009) on the proposed project list. Staff anticipates that design of PWCP 19-002 will be completed by August 2021, and construction completed by November 2021. Design of PWCP 20-006 is anticipated to be completed by March 2022, and construction completed by December 2022. Design of PWCP 21-009 is anticipated to be completed by September 2021, and construction completed by December 2021.

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017, in order to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our Lancaster are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City of Lancaster must adopt a list of all projects proposed to receive funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1 by resolution, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the Lancaster, will receive and estimated \$3,158,500 in RMRA funding in Fiscal Year 2021-2022 from SB 1; and

WHEREAS, this is the fifth year in which the City of Lancaster is receiving SB funding, and will enable the City of Lancaster to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City of Lancaster used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the community priorities for transportation investment; and

WHEREAS, the funding from SB 1 will help the City of Lancaster maintain and rehabilitate roads on major corridors and neighborhoods throughout the City this year, and dozens of similar projects into the future; and

WHEREAS, the 2018 California Statewide Local Streets and Roads Needs Assessment found that the City's streets and roads are in an at-risk condition and this revenue will help us increase the overall quality of our road system; and

In February 2021, City staff requested all prequalified consultants for SGC 2 of the Traffic Engineering Multi-Year Agreement, to propose on the project. Services included in SGC 2 are public outreach and education services, vehicle miles traveled (VMT) analysis and traffic operation and safety assessments, and transportation planning services.

The City received 5 proposals, and a review panel of 3 staff evaluated them for project understanding, approach, scope of work, schedule and capacity, and innovative approach. The panel determined the proposal from Redman Consulting, LLC, to be the most comprehensive, realistic, and innovative.

Project Understanding

The City of Lancaster completed a Safe Routes to School (SRTS) Master Plan in 2016, with the primary work being done between 2013 and 2014. In the years since that Plan was completed, significant changes to the built environment, school attendance zones, the economy, local work and travel patterns, and demographics have occurred, thus necessitating a "Refresh" of the profiles associated with each school's campus.

In addition, the City has completed several related transportation modal and safety plans, and has moved the City's infrastructure, along with public opinion and support, for a sustainable, complete streets, Vision Zero approach to infrastructure investments that aid local and regional mobility, circulation, safety and access. Specifically, the City has published its Master Plan of Trail and Bikeways (2012) with updated maps in 2020, the first Safe Routes to School Master Plan (2016), a Master Plan of Complete Streets (2017) and Safer Streets Action Plan/Systemic Safety Analysis Report (2020). These plans intersect and will inform the results of this proposed Refresh of the SRTS Master Plan. The City has also received notice (in April 2021) of state funding for a Local Roadway Safety Plan, to which this SRTS Refresh will provide input.

Another factor calling for a Refresh is that COVID-19 stay-at-home practices have doubtless changed routines, which will be assessed through Task 3's Community Engagement activities.

Finally, the See and Be Seen SRTS safety education program has begun, and this award-winning and innovative program will be delivering early results during the life of this SRTS Refresh. The Consultant and PDT will collaborate to get input from students and teachers, parents and administrators, about the effectiveness of different elements of the program. This will inform the updated Program Plan elements for each school profile.

Thus, this Safe Routes to School Master Plan Refresh (Refresh) will update the September 2014 work, and, specifically, revise the introduction and the individual school profiles now located on the City's website. The updated profiles will account for changes related to:

- School zoning, which resulted in changes in the routes students take
- Changes in travel patterns relative to the schools
- Other City Master Plans that intersect with the SRTS Master Plan
- All Capital projects that have been implemented since the SRTS Master Plan has been adopted that may impact the SRTS Master Plan
- Projects currently funded and that will be implemented and may impact the SRTS Master Plan
- Any other element of the City's transportation system, present or future, to ensure that the SRTS can be adapted to suit those elements.
- Updated photos, as needed, to document changes in existing conditions.

The SRTS Refresh will update the school profiles for each school, in light of new data, evolving understanding of best practices, and newly adopted plans at the local, county, regional and state levels, as well.

Project Assumptions

Consultant's cost proposal is based on the following assumptions related to the scope of work. If any of these are incorrect, or need to be modified, the cost to complete the project would accordingly rise or fall.

Primary project deliverables will be completed within 11-13 months, with an additional period for review, as needed, to accommodate school vacation periods. Consultant assumes stakeholder approvals for final "living document" from City, school districts and community during month 15, with the potential for two additional months to allow for presentation, Consultant support for school announcement events in August/September 2022, and final invoicing.

Project Includes the following school facilities:

- Four public school districts within the City of Lancaster's jurisdiction
 - Lancaster School District
 - o Eastside Union School District
 - Westside Union School District
 - Antelope Valley Union High School District
- Approximately 30 individual public schools (with potential for Antelope Valley Public Health to engage some of the private schools)
- Primary deliverables will include:
 - Extensive mapping, including "paper" (suitable for printing) and web-based interactive mapping with various data layers, to support community engagement and flexibility for City and school districts to re-draw attendance zones in the future.
 - Project-related content (as part of deliverables) for City-hosted website and event tabling, as well as presentations to elected officials and internal stakeholders.
 - o Two sets of SRTS tallies for all 30 schools (proposed).
 - o SRTS Project Status Matrix.
 - o Community Engagement Plan and Summary of Results.
 - o Input to Local Roadway Safety Plan, primarily through the Safety Assessment Tech Memo (Task 5).
 - School Profile PDFs, which will take the form of approximately 10-page mini-plans for each school, with updated crash maps, suggested route maps, photographs, community engagement highlights, and tiered project recommendations based on application of the Prioritization Framework to the menu of best practices.
 - o Introduction and Funding Resources Update, including city-wide and district-wide issues, systemic approaches and milestone schedules.

Overall Project Objectives

Project objectives include the following:

- Update school profiles to reflect relevant changes over the past several years
- Coordinate planning efforts with community members and project stakeholders to promote safe routes to school, in concert with the City's Vision Zero and complete street goals, and to increase community support for investments needed to increase the percentage of students (K-12) who safely walk, bike, skate, scoot or roll to school.

- Increase the attractiveness and mode share of active transportation for home-to-school and school-to-home trips.
- Minimize conflicts between roadway users, and students, and work toward the City's Vision Zero safety goals through improved engineering, education, and enforcement approaches.
- Improve public health by encouraging safe walking and cycling through best practices conceptual design for school trips.
- Improve safety conditions and reduce the number and severity of traffic collisions.
- Reduce GHG emissions and work towards a sustainable environment for generations to come.
- Leverage project lists and design guidelines in related local, regional, and state plans, to ensure alignment with approved guidance, and adherence to best practices

Summary of Project Tasks

Task 1: Project Management, Project Kickoff and Scope/Schedule/Budget Finalization

Redman Consulting (Consultant) will serve as the prime contractor for this project, with Kimley-Horn serving as subconsultant. Together, Redman Consulting and Kimley-Horn are the Consultant Team. The major division of tasks is that Redman Consulting is responsible for the overall contract and deliverables and will lead the outreach and many of the planning tasks or subtasks. Kimley-Horn will take lead on engineering and other technical tasks and subtasks, GIS and on-line mapping, student tallies, data collection and other tasks identified herein. Additionally, because KH has a permanent local presence, KH team members will provide support for tasks which require field work or in-person presentation or data collection. Deborah Redman has included pricing for three field visits, to be charged only if used, per City direction.

Consultant will manage and administer the project according to the executed contract between the City of Lancaster and the Consultant. The City and Consultant will hold a kick-off meeting that includes all relevant City staff, to discuss SRTS Refresh procedures and project assumptions and expectations, including invoicing, quarterly reporting, and all other relevant project information related to scope, schedule, budget and roles and responsibilities for the City and the Consultant.

Task Deliverables

- Project Kickoff meeting with City of Lancaster meeting notes
- Finalized Scope, Schedule and Budget
- Quarterly invoices and progress reports
- DBE reporting as required

Task 2: Existing Conditions, Best Practices & Evaluation Framework

In this task, Consultant Team will conduct a literature review, complete initial data collection, work with the city to update current SRTS project status, prepare a foundational citywide context map that will be used in the community engagement tasks (Tasks 3 and 4) to provide an easily accessible and understandable issues and constraint map and analysis. This issues and constraint map and analysis will be a "working document" that will be finalized when all stakeholders have provided input.

Additionally, Consultant Team will compile best practices for consideration and refinement during the life of the project and will prepare a prioritization framework which will use City

policies, state and national engineering standards and community values as primary inputs to provide prioritized project lists for implementation.

Task 2.1 Literature Review

Consultant Team will review the current SRTS Master Plan as well as other City plans including the Safer Streets Action Plan and several other recently completed planning documents. Consultant Team will also review the current state of the industry regarding Safe Routes to School plans from ITE, APA, and other known sources. At least three other exemplary SRTS plans will be reviewed.

Task 2.2 Data Collection

Consultant Team will coordinate with the City to gather data to assist with identifying and prioritizing infrastructure projects that need support and resources from the City. The data will include, but is not limited to:

- Approximate student residence and school attendance boundaries
- Student travel survey results
- Existing school transportation-related safety education or curriculum materials
- Car and pedestrian/bicycle collision data
- List of recent or proposed city's school safety projects and capital projects
- Bicycle parking available at each school
- Photographs of existing conditions at each school to update those taken previously

In early Fall 2021 (August or early September) KH will conduct an SRTS survey at all 30 public schools, using the SRTS Student Travel Tally.

Task 2.3 Project Status Matrix

Develop matrix of project status for all the schools and their projects. Matrix can show status as completed, in progress, or unfunded/unprogrammed. This information can be used to report on percent complete of current master plan and use the matrix to screen projects to answer some of questions identified in the RFP. The City will provide primary input as to project status.

Task 2.4 Citywide Interactive-Supported Context Mapping, Issues & Constraints

Using the City provided GIS base file and as data becomes available, Kimley-Horn will develop a layered map to show the street network, signalized and unsignalized intersections, school district zones, attendance zones, major land uses, travel patterns, collisions, demographics, and other pertinent information.

KH will also incorporate the data collected through the community outreach process. The objective of this task is to understand and analyze the interaction of these different elements on the school travel and attendance patterns. In addition to the feedback through in-person and virtual meetings, Consultant Team will use Kimley-Horn's interactive mapping software, PublicCoordinate, which provides a sophisticated online interactive process to solicit feedback from the public. This tool offers enhanced capabilities such as comment input, toggling between multiple project locations and base maps, ADA web accessibility, custom branding, survey integration, and so much more. Its online platform is user-friendly, making it easy for the public to provide input and visualize what their communities would look like with proposed transit, roadway, development, or infrastructure improvements.

Task 2.5 Student Tallies

Although COVID-19 will have certainly impacted previous travel patterns, even as students return to in-person classroom settings, the Consultant Team will need a Fall 2021 baseline mode split for multiple Project purposes.

KH will lead update of the travel patterns for each school using the **SRTS tally sheet** available at http://guide.saferoutesinfo.org/evaluation/appendix a safe routes to school student travel ta

<u>lly.cfm</u>. This guide was developed by the Pedestrian and Bicycle Information Center (PBIC) in collaboration with SRTS experts from around the country and support from the National Highway Traffic Safety Administration (NHTSA), Federal Highway Administration (FHWA), Centers for Disease Control and Prevention (CDC) and Institute of Transportation Engineers (ITE). Since the current plan already includes travel patterns for each school, we can analyze if any of the school patterns have changed using this tally sheet.

The survey will be conducted for two to three typical weekdays from Tuesday to Thursday. The results of the survey will be compared to the results included in the 2016 SRTS Master Plan.

Additionally, to allow the City to have access to as "normal" a set of results as possible, a second wave of all 30 schools will be surveyed, using the same technique as described above, as late in the Project process as possible (late Spring 2022), in consideration of needs for data inputs into the 2022 Caltrans Active Transportation Program grant cycle.

Going forward, each year there will be updated tallies at five selected schools, to be conducted by the schools or the City.

2.6 Menu of Best Practices

Based on the Literature Review and City and community input, Consultant Team will develop a preliminary menu of best practices for safety and accessibility, using the six "e's" - engineering, evaluation, equity, education, encouragement, and enforcement strategies. The menu will be updated and annotated during the life of the Refresh project and will be drawn upon for specific projects for inclusion in the school-specific updates.

2.6 Prioritization Framework

Consultant Team will work with the City to develop project-level as well as systemic criteria and weighting methodology to prioritize candidate school improvements identified in Tasks 2 and Task 5.1. The criteria and weighting methodology will be based on multiple factors such as City, school, parent and student identification of concerns and values, existing student travel, existing school resources, estimated cost, constructability, and operations and maintenance. Consideration of funding opportunities, grant programs and constraints will also be included as a second-tier prioritization factor. This effort will be coordinated with the City's Local Roadway Safety Plan. Consultant Team will summarize the methodology in a memorandum to the City.

- Draft and Final Prioritization Framework

Task 3: Project Development Team (PDT) & School Advisory Team (SAT) Meetings Task 3.1 Project Development Team (PDT)

In the context of Consultant reporting to City Project Manager in the Community Development Department, this task will establish a Project Development Team for additional technical day-to-day project direction, with coordination meetings every two weeks, or as needed. The PDT includes at a minimum the Lancaster City staff responsible for traffic and safety analysis, project development, implementation, and maintenance.

Proposed PDT composition from the City of Lancaster:

- Community Development (Candice, Vander Hyde, Project Manager)
- City Manager's Office (as needed)
- Planning Department, Traffic Engineering, Public Works, and Parks departments

Task 3.2 Establish a School Advisory Team (SAT)

A School Advisory Team (SAT) will be established, including principals from each school, as well as representatives from each school district, providing input on district policies, capital planning and access/egress issues specific to their respective schools. In addition to providing input at the beginning of the SRTS Refresh, the SAT will review draft materials as they are produced, from their unique district-level and school-specific perspectives

Proposed SAT composition:

- Administrative, transportation and capital planning staff from each district (Lancaster School District, Eastside Union School District, Westside Union School District, and Antelope Valley Union High School District)
- Principals from each school
- Antelope Valley School Transportation Agency
- Antelope Valley Partners for Health + affiliated groups (youth, CBOs)
- Los Angeles County Department of Public Health
- Los Angeles County Sheriff's Department (as needed)

Task 3.3 School District On-Line Workshops: Consultant will lead four school-district-wide workshops, strategically timed to provide meaningful input into the development of the remaining scope of work, approach and deliverables. These District-level workshops will include district-level management and staff, and will last one hour, and will be used to help Consultant and the City do the following:

- Identify district-level trends, issues, initiatives relevant to SRTS
- Get updated student data
- Garner District support for the City's efforts to gather input from each school
- Develop plans for student trip-making tallies (potentially in September, when COVID-related anomalies may have resolved)
- Discuss candidate locations for possible school-specific in-person safety workshops (led by KH)
- Identify contacts for inclusion in the Community Engagement effort (active students, teachers, crossing guards, parents, community-based organizations)
- Identify priority populations and vulnerable groups
- Understand the District perspective on the See and Be Seen program to date

Task 3.4 School-Specific Focus Groups: To follow up on specific issues related to SRTS needs, aspirations, travel patterns, concerns, Consultant Team will lead up to 30 school-specific focus groups with relevant school staff, and at least one member of City of Lancaster staff. These meetings will be limited to 30 minutes, to increase likelihood of participation, and if possible, email surveys or questionnaires will be used to substitute for the focus groups, or to supplement the information.

Task Deliverables

 Meeting invitations, presentation materials, agendas, focus group scripts, meeting summary notes, list of attendees, list of action items through life of the Project.

Task 4: Community Engagement

4.1 Community Engagement Plan to Identify and Address Community Needs: In coordination with the City and PDT, Consultant will develop a CEP based on conditions in 2021-2022, and the project scope of work. The primary purpose of this task is to identify community needs, based on changes in existing conditions near schools (projects that have been built, or are funded or planned)

To supplement the two waves of student tallies described in Task 2.3 and to obtain more information from specific communities, especially priority populations, and those with disabilities, additional student tallies and/or surveys of parent attitudes, concerns and needs assessments will be conducted, along with other techniques, such as bill inserts, the City's webpage, the project webpage, and school announcements and flyers or email blasts to direct traffic to the interactive maps and/or on-line survey instruments, or events at which the City will be staffing informational tables.

The Consultant Team will work with the PDT and SAT to develop all survey instruments, and KH will provide translation into Spanish language for key pieces of official engagement materials (primarily fact sheets and survey instruments).

For any potential in-person events, safety workshops or demonstrations (using SCAG's kit-of-parts, e.g.) a range of outreach and engagement strategies, events, venues, locations, days, and times, will be included, to maximize the ability of all groups, particularly those representing special needs populations and disadvantaged communities, to actively participate through to conclusion of the process to refresh the SRTS school profiles

As part of each major event, the community will be surveyed to understand how to improve the next event.

Expanded Community Engagement Stakeholders List: Based on information from the districts and schools in Task 3, a list of relevant community stakeholders, including all including parents, school administration, students, crossing guards, and community-based organizations, neighborhood associations, business organizations, development interests, and modal advocates, will be included, as appropriate.

A special focus on including representation and meaningful input from all voices of disadvantaged communities, priority populations and vulnerable populations, will help ensure that the SRTS Refresh efforts address community-identified needs.

COVID-19 Impacts: Although it is anticipated that COVID-19 restrictions on gathering will be gradually loosened over the course of 2021 and possibly early 2022, when the community engagement activities will occur, the CEP will include strategies to accommodate the potential of a similar disruption.

Leveraging Previous Digital Success: Note that even prior to the pandemic, the City has had great success in digital engagement with the community, using innovative, fun and easily accessible interactive maps to identify community concerns and elicit specific comments and suggestions. These strategies will be included in the CEP, as they are naturally "COVID-proof."

All proposed "in-person" events described below will have virtual alternatives identified.

Engagement Strategies: The following are proposed as relatively COVID-proof ways to engage community stakeholders, and to provide a two-way interaction between the community and the PDT/Consultant team, as described below.

4.2 Project Web Page Content and Interactive Project Map and Web Based Survey(s)

Consultant Team and City will meet with City IT staff to understand capabilities of current website to host planned interactive map, surveys and webinars. Potential adjustments to some web content may result, in concurrence between the Consultant Team and the City.

Consultant Team will work with City to develop content for project web page and establish interactive project maps for each school. Much of this material will come from Task 2 deliverables, but may be shaped for public-facing purposes and accessibility. Potential project web-based surveys will be hosted on this site, along with presentation materials, draft deliverables, etc. It is assumed that Consultant Team will provide maps, and compile results, but not create the interactive website itself.

As a potential augmentation of school-based student trip tallies and the interactive project map results, additional mini-surveys may be developed to increase input on specific issues, or to gain more participation from specific communities of concern and priority or vulnerable populations. It is assumed that the City will administer the surveys, and that the Consultant will prepare up to 5 unique place-specific or topic-specific survey instruments in English, for City translation into Spanish.

4.3 Project Fact Sheet: Consultant will work with PDT to introduce project goals, scope, timeline, and input opportunities. City and Consultant will provide public with understanding of Project purpose and progress, as well as highlight public engagement and input opportunities. Suggestions for improving public access will be solicited from the public. KH will translate all fact sheets into Spanish language.

4.4 Optional Temporary Design Solution(s) Demonstrations

Install temporary demonstrations, where possible utilizing Go Human Kit-of Parts, and host one or more community demonstration events, based on what the community would most like to "experience" prior to recommending. SCAG available treatment option kits (currently parklet, curb extension, artistic crosswalk, separated bike lane and median refuge island) would assist in public engagement and feedback. [Note that this is separately priced as option. Final pricing TBD by the vendor, SCAG.]

4.5 Lancaster Event "Project Table" Materials Development

This activity assumes that City staff will attend local fairs, pop-ups, farmers' markets and other civic events, and seek input from the community on SRTS issues. Consultant will assist with development of boards, brief survey instruments, and fact sheet updates. KH will provide table surveys and fact sheets in Spanish.

4.6 Draft and Final Community Engagement Report

Consultant will prepare a draft and final report, including a summary of the public engagement process, participation, outcomes, and resulting preferred treatments at each school. This product will help the City in future funding pursuits, as it may need to document how community input affected engineering and programmatic recommendations.

Task Deliverables

- Community Engagement Plan (CEP)
- Draft and Final List of Community Stakeholders
- Draft and Final Project Fact Sheets (English and Spanish)
- Post-event surveys, results and actions taken
- Interactive Map Development; Social Media, Compilation and Analysis of Public Comments
- Web Page; Interactive Map Development; Web Based Surveys, Compilation and Analysis of Public Comments
- Up to 3 1-day temporary design demonstrations,
 - o Report, Photographs, Comments
- Task 3 Draft and Final Report

Task 5: Safety Assessment 5.1 Up to 8 Safety Workshops at Selected Schools

Consultant will develop a plan to conduct workshops, in coordination with PDT and SAT, and will conduct the workshops and prepare draft and final workshop summary reports. Results will feed into the final menu of best practices, the prioritization framework, the universe of candidate strategies and the final city-wide, district-wide and school-specific recommendations.

Ideally, at least one safety workshop will be conducted in each of the four school districts, but the primary focus will be on identifying a minimum of four (4) and up to eight (8) schools to hold safety workshops, where a variety of relevant characteristics will be in evidence. For example, a range of crash rates or types, differences in built environment (suburban, major arterial, etc), school type (elementary, middle and high schools), community demographics and/or safety issues already known. The Consultant Team will work with the PDT and SAT to identify the mix of schools that will best yield an understanding of safety issues that can be addressed systemically. The Consultant Team will prepare a workshop plan, for review by the City/PDT and which will be finalized for implementation.

Based on their in-depth experience with similar projects, Kimley-Horn has found hosting a school workshop and traffic safety assessment with stakeholders (school/district staff, school faculty, parent teacher association representatives, students, etc.) to be helpful and insightful when assessing or identifying any transportation needs at or near the school site. Kimley-Horn anticipates hosting up to four (4) in-person workshops.

At these school workshops, participants will include stakeholders for each school and will be requested to comment on transportation problems and safety or severance hotspots. As part of the workshop, Kimley-Horn will lead one traffic safety assessment during either the school morning drop-off or pick-up period. The preferred observation period will be selected in coordination with the school. The traffic safety assessments will include observing drop-off/pick-up operations and walking and bicycle activity, note infrastructure deficiencies, and assess opportunities for safety and operational improvements. Following the traffic safety assessment, the group will convene inside the school to discuss potential improvements.

5.4 Safety Assessment Tech Memo

Kimley-Horn will review data collected in Task 1, 2.1 and 2.2, and review the City's recent and proposed school safety projects to identify existing infrastructure deficiencies, as well as recommended improvements in the public right-of-way at/near each school, as well as revisions to suggested routes to schools. Results and recommendations will be summarized in a traffic assessment technical memorandum.

Task Deliverables

- Safety Workshop Plans, Materials, Summary Results
- Draft and Final Safety Assessment Tech Memo

Task 6: School Profile Updates - Photos, Crash Data, Improvements & Routes Maps

6.1 School Area Photographs (As Needed)

In order to document specific or significant changes or issues near schools, Consultant and/or City will take new photographs for illustration within the school profiles.

6.2 Collision Map Updates

Using the California Transportation Injury Mapping System, consultant will update each of the school area bicyclist and pedestrian crash maps for the most recent five-year period. A

discussion with the City and Caltrans may be needed to understand how to treat pandemic impacts to data. If desired, heat maps of schools, or larger areas showing area-wide data, can also be included.

Working with the PDT and the SAT, Consultant will update the Improvement Plan map for each school.

6.3 School Area Improvement Plan Map Updates

As the City traffic and public works staff identifies changes to the current slate of improvements near each school, Consultant will update them on the school profile maps.

6.4 Suggested Route Map Updates

Working with the PDT, the SAT and with input from proposed activities in Task 4 and Task 5, revised "suggested routes" maps will be created, with updates to all items in the current map legend, including entrance gates, bus loading, bike parking, parent drop-off/pickup, existing flashing beacons, smart cross walks, traffic signals, and enrollment boundaries. The Consultant team will use the base maps created in Task 1 as the foundation for these maps.

Task Deliverables

- Bike/Ped Crash Maps Updates (TIMS)
- School Area Improvement Plan Maps
- Suggested Route Maps

Task 7: School Profile Updates Existing Conditions, Engineering Recommendations, and Educational/Encouragement Plan Program Updates 7.1 Existing Conditions Updates (School PDFs)

During Task 2, the "existing conditions" maps will be initially updated within the first two to three months, so that they can be used in the CEP's proposed interactive maps, in order to elicit comments on current and near-term future needs perceived by the community. Existing conditions will include funded capital improvements that will affect schools and will be called out as such for the interactive map input.

As part of Task 7, final updates to the City's web-based PDFs showing existing infrastructure conditions schematic drawings and maps will be created by the Consultant, based on previous Tasks. Consultant Team will create updated existing conditions and engineering improvements for the infrastructure accessing each school.

7.2 Engineering Recommendations (KH is Lead)

Consultant Team will work with City, to incorporate results of community and school stakeholders, and develop recommendations using the prioritization framework and ensure alignment with relevant local plans and regional and state guidelines.

Project prioritization will be included (e.g., first and second tier needs). This will help support future grant or other funding pursuits.

7.3 Program Plan Recommendations (RC is Lead)

Based on assessments of existing programs (See and Be Seen), and in consideration of the Menu of Best Practices, along with analysis of crash data and Task 3 and 4 input, Consultant will work with PDT to update the Program Plan recommendations for safety education and active transportation encouragement at each school. These could include extensive suggestions for post-COVID return to normalcy for students, parents and school communities.

8.1 Introductory Pages

This task will produce an update, or replacement, of the 2016-era introductory pages, to provide proper context for understanding the updated school profiles. It will update the school tallies of mode share, speed and safety trends, and provide a new summary of federal, state, regional and local funding programs and opportunities, which have evolved and will change over coming months due to a new administration's changing priorities, and responses to the economic impacts of the pandemic. The update of this section, including a plan to make it a "living document" through such strategies as rolling school tallies for 5 schools each year, will be particularly important to understanding the funding context in 2021 and beyond.

8.2 School Profile PDF Updates

This task delivers the draft and final School profile PDFs for each of the individual schools, that can be uploaded to the City's website. Each school profile update will be approximately 7-10 pages in length, and constitute "mini-SRTS plans" that can be used to document best practices solutions for schools that are support by the community, the schools and the City, as the City seeks funding to implement them.

Recommendations:

- Approve a Memorandum of Understanding with TRU 2005 RE I, LLC related to the proposed development of the former Toys "R" Us center on the northeast corner of Avenue K and 15th Street West.
- 2. Authorize the City Manager or his designee to finalize and execute all related documents.

Fiscal Impact:

None.

Background:

Since the closure of Toys "R" Us in 2018, staff has been collaborating with the development team responsible for Toys "R" Us' former assets to redevelop the site. Located on Avenue K and 15th Street West just off the 14 Freeway, the site is a key intersection and point of entry to the City of Lancaster.

Staff has communicated both the importance of the site and the City's desire to see new tenants not currently present in the Lancaster market. The developer has worked to meet this goal, securing letters of intent from at least two tenants that have long been requested by Lancaster residents.

The proposed Memorandum of Understanding ("MOU") would memorialize a number of items that have been discussed in order to advance the development of the site, which include:

• The City's street improvements and installation of a traffic signal associated with the Avenue K freeway interchange project, previously budgeted as part of the City's various grant-funded interchange projects

- Expedited permitting as a key economic development project
- A commitment to collaborate in good faith on a "Welcome Feature" and signage to promote both the City of Lancaster, as well as the center and its tenants

The City will continue to provide support throughout the development review process, as well as assistance with retail recruitment. The MOU aims to aid in attracting still more high-quality tenants by documenting the discussions between the City and developer to date.

The proposed center is projected to create at least 120 new jobs and generate significant sales tax revenue to the City.

Memorandum of Understanding Between TRU 2005 RE I, LLC and City of Lancaster

This MEMORANDUM OF UNDERSTANDING ("*MOU*") is entered into on _______, 2021 ("*Effective Date*"), between TRU 2005 RE I, LLC, a Delaware corporation ("*TRU*"), located at 1335 West Avenue K, Lancaster, California 93534 and the CITY OF LANCASTER, a municipal corporation ("*City*").

WHEREAS, TRU owns that certain approximately 9.35-acre parcel of land located in the City of Lancaster, County of Los Angeles, State of California, as more particularly described on **Exhibit "A"** attached hereto ("*Property*"). The Property previously included commercial retail uses located in several buildings with a total square footage of approximately 120,734 square feet.

WHEREAS, the City is preparing to start construction on a fully-funded road improvement project along West Avenue K and 15th Street West ("Road Improvements"), as generally depicted on Exhibit "B" attached hereto ("Site Plan"). The Road Improvements include the addition of a dedicated right-hand turn lane at the intersection of West Avenue K and 15th Street West, which will encroach onto the Property by approximately 0.17 acres and will also require the relocation of an access point to the Property on West Avenue K, as identified on the Site Plan.

WHEREAS, in connection with the Road Improvements, the City has planned, budgeted and contracted to install a four-way traffic signal at the middle access point to the Property along 15th Street West ("*Traffic Signal*"), as more particularly detailed on <u>Exhibit "C"</u> attached hereto.

WHEREAS, the City's proposed timing for the Road Improvements and Traffic Signal will likely be coterminous with TRU's construction schedule for the proposed reuse of the Property ("*Reuse Project*"), and, as such, certain demolition, utility, and other construction work may be accomplished more efficiently through cooperation of the Parties (hereinafter defined).

WHEREAS, TRU is diligently pursuing approvals for the Reuse Project, and is actively negotiating with certain future tenants and end-users for space within the Property ("*Users*").

WHEREAS, in connection with the Reuse Project, TRU and the City (each, "Party" or collectively, "Parties") have discussed a wide range of commercial uses permitted under the current zoning of the Property to ensure that the individual tenants and uses of the Reuse Project are viable and thus attract quality tenants to Lancaster.

WHEREAS, in connection with the Reuse Project, TRU intends to construct a monument sign at the corner of West Avenue K and 15th Street West, which sign is intended to display the names of the Users ("*Sign*"), and the Parties wish to work cooperatively to design and construct landscaping and the Sign to act as a gateway to the City of Lancaster ("*Welcome Feature*").

NOW THEREFORE, this MOU shall govern the terms and conditions between the Parties regarding the Reuse Project as more particularly set forth herein.

1. Road Improvements.

- a. TRU and the City will use commercially reasonable and good faith efforts to negotiate a permanent right-of-way easement to accommodate the City's planned Road Improvements ("ROW Easement"). The ROW Easement shall include, but not be limited to, the following provisions: (i) the City shall pay all hard and soft costs related to construction of the Road Improvements as previously approved in City budgets and contracts, (ii) the Parties shall mutually agree as to the allocation of costs related to any landscaping, the Welcome Feature, or any beautification related thereto; (iii) the City shall be responsible for maintenance of all Road Improvements for the duration of the ROW Easement; and (iv) a reservation of rights in favor of TRU in order to construct and maintain the Sign pursuant to plans and specifications reasonably approved by the City. TRU and the City shall collaborate in good faith to determine features and costs of the Sign that are mutually beneficial and agreeable to both Parties.
- b. In connection with the Road Improvements and the corresponding dedicated right-hand turn lane at the intersection of West Avenue K and 15th Street West, the City has budgeted grant funds and shall contract to relocate, at the City's sole cost and expense, the westerly access point to West Avenue K to the location shown on the Site Plan.
- c. The City and TRU agree to use commercially reasonable and good faith efforts to identify efficiencies in connection with the proposed Reuse Project and the City's planned Road Improvements in order to minimize construction timing and to limit duplicative construction costs. Such efficiencies may include demolition labor, utility connections, landscaping, and other costs, expenses, or requirements which may be necessary for the construction of both the Reuse Project and the Road Improvements.
- 2. <u>Traffic Signal</u>. The City acknowledges and agrees that the City shall install the Traffic Signal, at the City's sole cost and expense, in connection with the Road Improvements as

outlined in previous City grant funded budgets and agreements. Installation of the Traffic Signal shall include any and all necessary equipment, curb cuts, aprons, utility facilities, signage, and other improvements or structures related to the Traffic Signal as allowed by granting agency.

- 3. Permitting. The City stands in strong support of the reuse of the Property for a wide variety of commercial uses permitted by the City's Municipal Code. The City champions the many benefits of the proposed Reuse Project to the local community, including job creation; tax base enhancement; and a variety of new amenities for local residents. As such, the City has designated the reuse of the Property as a priority for the City. Accordingly, the City is committed to assisting in expedited permitting of the Reuse Project subject to compliance with all applicable laws, including, without limitation and, if necessary, the California Environmental Quality Act; easy access to Economic Development and development review staff support as needed; marketing and promotional support from the City's Communications team as desired; and more.
- 4. <u>Disruption</u>. In connection with the Traffic Signal and Road Improvements, as set forth in Sections 1 and 2 above, the City shall use commercially reasonable efforts to minimize disruption of the ordinary operation of the Property, including, but not limited to maintaining access and parking to a standard reasonably equivalent to that approved with Planning Case DR 21-25 Site Plan in <u>Exhibit "B."</u>
- 5. <u>Liability</u>. Each Party to this MOU shall be responsible for its own acts and omissions and those of its officers, employees, and agents. No Party to this MOU shall be responsible for the acts or omissions of entities not a Party to this MOU.

6. Miscellaneous.

- a. Each Party has the right and authority to enter into this MOU and to perform its obligations contemplated herein.
- b. This MOU and the rights of the Parties hereunder shall be governed, construed, and interpreted in accordance with the laws of the State of California.
- c. The headings in this MOU have been inserted for convenient reference only and shall not be considered in any questions of interpretation or construction of this MOU.
- d. The provisions of this MOU are severable and independent, and if any such provisions shall be determined to be unenforceable in whole or in part, the

remaining provisions and any partially enforceable provision shall remain binding and enforceable.

- e. This MOU contains the entire understanding between the Parties hereto and shall not be modified, amended, or supplemented, or any rights herein waived, unless specifically agreed upon in writing by the Parties.
- f. Recommendation:

Adopt **Ordinance No. 1084**, amending the zoning designation on 4.43 acres of land located on the southeast corner of 10th Street West and Avenue K-8 (Assessor's Parcel Number 3128-004-016), known as Zone Change No. 19-02, from Specific Plan (SP) to Commercial Planned Development (CPD).

Fiscal Impact:

None.

Background:

In 2019, the applicant, Shamsian Holding, LLC, submitted a General Plan Amendment (GPA), Zone Change (ZC), and Conditional Use Permit (CUP) for a proposed project located at the southeast corner of 10th Street West and Avenue K-8. Staff reviewed the proposed project and prepared a staff report (Attachment A), recommending to the Planning Commission approval of the GPA, ZC, and CUP. The Planning Commission held a public hearing on the request on April 19, 2021 and voted (by a 7-0-0-0-0 vote) to recommend approval to the City Council for the GPA and ZC, and approval of the CUP to allow for the construction and operation of a commercial mini-mart, gas station fuel canopy, four commercial buildings, and to allow the sale of alcohol with a Type 20 (off-sale beer and wine) Alcoholic Beverage Control (ABC) license.

The applicant is requesting to amend the General Plan land use designation from SP to C, and rezoning the subject site from SP to CPD, to allow the subject property to be developed with a commercial development. The GPA and ZC would be consistent with the goals, objectives and policies of the Lancaster General Plan 2030, because it is not incongruous with existing land-use patterns, or the character of the surrounding area. Therefore, staff is recommending approval to amend the General Plan land use designation from SP to C, and change the zoning designation

from SP to CPD.

WHEREAS, pursuant to Section 17.24.060 of the Lancaster Municipal Code, an application has been filed by Shamsian Holding, LLC ("Applicant") to change the zoning designation on 4.43 acres of land that is located on the southeast of 10th Street West and Avenue K-8 (Assessor's Parcel Number: 3128-004-016) from Specific Plan (SP) to Commercial Planned Development (CPD); and

WHEREAS, a notice of intention to consider a zone change of the subject property was given, as required by Section 17.24.110 of the Lancaster Municipal Code, and Sections 65854 and 65905 of the Government Code; and

WHEREAS, on April 19, 2021, the City's Planning Commission held a public hearing on the General Plan Amendment No. 19-01 and Zone Change No. 19-02, notice of which was published and provided as required by law, and adopted Resolution No. 21-06 ("Planning Commission Recommendation"), recommending the City Council approve General Plan Amendment No. 19-01 and Zone Change No. 19-02; and

WHEREAS, the Planning Commission adopted and certified that it has reviewed and considered the information in the Mitigated Negative Declaration prepared for the proposed project in compliance with the California Environmental Quality Act ("CEQA") (including its implementing regulations). The Planning Commission found that the Initial Study determined that the proposed project could have a significant effect on the environment; however, there will not be a significant effect in this case with the implementation of the mitigation measures as detailed in the Mitigated Negative Declaration. The Planning Commission found, pursuant to Section 21082.1 of the Public Resources Code, that the Mitigated Negative Declaration prepared for the proposed project reflects the independent judgement of the City of Lancaster.

WHEREAS, staff has performed the necessary investigations, prepared a written report, and recommended that the zone change request be approved; and

WHEREAS, the City Council desires to approve the Applicant's request as set forth herein.

THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, DOES HEREBY ORDAIN, AS FOLLOWS:

- Section 1. The foregoing Recitals are true, correct and a substantive part of this Ordinance.
- Section 2. The City Council hereby makes the following Zone Change findings pursuant to Section 17.24.120 of the LMC:
 - a. That modified conditions warrant a revision in the zoning plan as it pertains to the area or district under consideration; and
 - b. That a need for the proposed zone classification exists within such area or district; and
 - c. That the particular property under consideration is a proper location for said zone classification within such area or district; and
 - d. That placement of the proposed zone at such location will be in the interest of public health, safety and general welfare and in conformity with good zoning practice.
 - Section 3. The subject property is reclassified from SP to CPD.
- Section 4. Any ordinance previously adopted by the City Council shall be and is hereby repealed if and to the extent inconsistent with this Ordinance, provided, however, that each such ordinance shall otherwise remain in full force and effect.
- Section 5. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is held for any reason to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance and each section, subsection, sentence, clause, phrase or portion thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, phrases or portions be declared invalid or unconstitutional.
- Section 6. The Mayor shall sign and the City Clerk shall certify to the passage and adoption of this Ordinance, and shall cause the same to be published and posted pursuant to the provisions of law in that regard, and this Ordinance shall take effect 30 days after adoption.

Subject: Concert at Lancaster Municipal Stadium Funding Request

Recommendation:

a. Allocate \$88,000 from the general fund to account 101-4649-575 to cover costs associated with the Trace Adkins concert on June 27, 2021.

Fiscal Impact:

\$88,000 in general funds to be allocated for event costs. The PARCS Department has an existing \$180,000 in the FY20/21 adopted budget, which will also be utilized for event costs. The total cost of the event is estimated to be \$268,000.

Background:

The City of Lancaster is known for year-round special events throughout the community. Due to the COVID-19 pandemic, many of the events the City traditionally held had to be cancelled. Furthermore, the funding for special events and programs were redirected toward resources to keep the community safe and healthy.

During the budget process for 2020-2021, the City Manager and the Finance Department presented a balanced budget. In order to be able to accomplish this and with the uncertainty of the pandemic, the PARCS special events budget was substantially reduced. Sufficient funding was allocated to cover the costs associated with the Christmas Drive thru event on the Blvd, the MLK Day of Service, the Food Distribution, and a general special event line to cover costs associated with the Egg Hunt Extravaganza, drive-in movie nights at the stadium, and the Poppy Festival. Unfortunately, with COVID-19 restrictions the Poppy Festival could not be held.

Now with the LA County currently in the yellow tier, the City's PARCS Department has scheduled a live outdoor concert at Lancaster Municipal Stadium on June 27 at 8pm. Trace Adkins will bring *The Way I Wanna Go Tour* to Lancaster. This will be one of the first live events in Los Angeles County and we are proud to be on the forefront of live events returning by offering this concert to the community.

This concert is projected to cost an estimated \$268,000. There is \$180,000 available in existing budget accounts, therefore the PARCS Department is requesting an additional \$88,000 to cover the remaining expenses that will be associated with hosting this event. The cost of the artist and necessary staging through an audio/visual contractor is \$180,000. The remaining costs include marketing, hospitality, logistics, branding, and décor.

This will be ticketed event, with a charge of \$25 per ticket for attendees in the existing seats at the venue. There is also an opportunity for attendees to purchase preferred group seating at tables on the infield at \$400 per table. This event is projected to have a revenue of \$100,000, which will offset the additional funding request.

The event will be a great jumpstart to our special event season, provide for community engagement, and allow our community to return to the socialization they desire. The request for additional funding will cover the expenses associated with an event of this magnitude.

Subject: Loan Agreement with Friends of the Antelope Valley Fair, Inc.

Recommendations:

- 1. Authorize the City Manager or his designee to negotiate and enter into a loan agreement with Friends of the Antelope Valley Fair, Inc., in the amount of \$250,000.00 for completion of the Antelope Valley Rural Museum.
- 2. Authorize the City Manager or his designee to finalize and execute all related documents.
- 3. Appropriate \$250,000.00 from Account No. 101-2900-000, Fund Balance to Account No. 101-1100-000, Accounts Receivable.

Fiscal Impact:

\$250,000.00 to be repaid with interest at the Local Agency Investment Fund rate after two years.

Background:

In 2009, members of the Antelope Valley Fair's Rural Olympics Committee and interested community members founded the Antelope Valley Rural Museum ("AVRM"). Catalyzed by the creation of the Rural Olympics Hall of Fame just a few years prior in 2005, AVRM has grown to encompass a wide range of displays and exhibits designed to tell the history of the Antelope Valley. These exhibits include early indigenous history, agriculture and its role in the settlement and growth of the Antelope Valley, tributes to local and fallen members of law enforcement and the military, and more.

In the ensuing decade, members of AVRM and the Antelope Valley Fair worked to raise funds to establish a permanent home for the museum. Construction began in 2019 on a new facility at the Antelope Valley Fairgrounds, which will provide more than 10,000 square feet of exhibition space, a kitchen, and a small meeting space.

The facility's shell is now complete. The proposed loan of \$250,000.00 would allow for accelerated completion of the museum's interior, thus, helping to make AVRM's extensive and growing collection accessible to the community as quickly as possible.

The term of the loan will be two years, with no payments due until two years following execution. The full amount, with interest accrued in accordance with the Local Agency Investment Fund ("LAIF") rate, will be due in a balloon payment at the end of the term. The loan may be repaid at any time in advance of the due date with no prepayment penalties.

Western Insurance Company Bond Claim

Recommendation:

Recognize revenue totaling \$2,413,423.82 in Western Insurance Company payments and increase appropriated expenditures and Capital Improvement Program (CIP) projects totaling \$2,400,000.00.

Fiscal Impact:

Approval of this action would result in an overall increase in recognized revenues totaling \$2,413,423.82, and an increase in appropriated expenditures and CIP projects totaling \$2,400,000.00, as detailed in Exhibit 1.

Background:

During the economic down-turn in 2007-2008, several tracts in the City were abandoned prior to completion and acceptance of grading and conditioned public improvements. In order to complete the improvements and/or make abandoned tracts safe, the City submitted claims on grading and improvement securities in accordance with the Undertaking Agreement for each tract.

One such claim was to Western Insurance Company for fourteen (14) tracts in the amount of \$41,065,252.35. Subsequent to the economic down-turn, Western Insurance Company entered into liquidation. In a letter dated March 7, 2012, the City submitted Proof of Claim relative to the liquidation of Western Insurance Company as the obligee with respect to various grading permits, labor and materials and performance bonds issued by Western Insurance Company.

In a letter dated March 4, 2014, the Liquidator of Western Insurance Company notified the City that \$9,180,293.96 of our claims for seven (7) tracts were approved, pending review and approval by the Court pursuant to Utah Code Annotated Section 31A-27a-608, and would be distributed on a pro-rata percentage of assets available for distribution.

Subsequent to this notification, four (4) tracts were purchased, securities were substituted, and claims for those tracts were withdrawn. The approved amount was reduced to \$3,447,748.32 for the three (3) remaining tracts.

The amount received, \$2,413,423.82, is a partial payment (70%) towards the approved amount of \$3,447,748.32.

City Council Recommendation:

City Council and City Council acting as Lancaster Housing Authority, Lancaster Choice Energy and Lancaster Power Authority conduct the public hearing and direct staff to schedule the Proposed Fiscal Year 2021-2022 Budget and Five-Year Capital Improvement Plan (CIP) adoption for June 22, 2021.

California Choice Energy Authority (CCEA) Board Recommendation:

Conduct the public hearing and direct City of Lancaster staff to schedule the CCEA Proposed Fiscal Year 2021-2022 Budget adoption for June 22, 2021.

Fiscal Impact:

The City of Lancaster Proposed Fiscal Year 2021-2022 Budget and Five-Year CIP totals \$270.8 million, including \$75.0 million for the Capital Improvement Program (CIP) and \$15.5 million in transfers out. The CCEA Proposed Fiscal Year 2021-2022 Budget totals \$1.6 million.

Background:

City of Lancaster Budget

By July 1 of each year, the City is required to adopt a budget, which establishes appropriations and estimates revenue for the coming fiscal year. The proposed budget is a culmination of many months of work by the City Council and staff in reviewing priorities and evaluating programs, with a focus on maintaining responsive and relevant services for residents.

City Council's priorities addressing:

- Sound fiscal foundation and resilience;
- Protect city infrasturture;
- Public safety;
- Measure LC appropriations;
- Economic development; and
- New facilities, programs, and service

have been incorporated into the City's Proposed FY 2021-2022 Budget.

The following table summarize the proposed citywide budget:

Estimating revenues for the upcoming fiscal year and forecasting out-years is essential. By reviewing past years' actual revenue receipts, new revenue sources, fee-based program and service projections, grant opportunities, and the State's economic outlook, the City is able to best determine the revenues available for spending allocations. The City estimated FY 2021-2022 revenues and transfers in total \$259.7 million.

The City's largest unrestricted funding source is the General Fund, totaling \$104.0 million, including transfers in. General Fund resources include property tax, sales tax, fees, grants, and others. Property tax is the top General Fund source, which is projected at \$25.0 million. The proposed General Fund appropriations total \$102.9 million, including \$2.8 million for the Capital Improvement Program (CIP) and \$12.8 million in transfers out.

The City of Lancaster desires to maintain a prudent level of financial resources to guard its residents against service disruption in the event of unexpected, temporary revenue shortfalls or unanticipated expenditures. Reserves accumulated during years when revenues exceeded expenditures cushion the City's transition to a lower revenue base and allow the City to adjust spending in response to economic downturns, emergencies, State revenue takeaways, and/or investment opportunities. The Proposed FY 2021-2022 Budget greatly recognizes and strengthens the City Council's priority of fiscal prudence and discipline with reserves totaling approximately 30%.

To continue transforming the City, we must continue focusing on the infrastructure in the City; we accomplish this through our Capital Improvement Program (CIP). We are persistent in our aggressive, proactive approach to allocating more capital improvement monies than ever before. The CIP for the Proposed FY 2021-2022 Budget totals \$75.0 million.

The Proposed FY 2021-2022 Budget addresses community needs, while maintaining healthy General Fund Reserves that will enable the City to continue providing the community with a full scope of high quality municipal services, programs and special events that enhance the quality of life of all Lancaster residents. It will also provide the required resources to construct significant capital improvement projects that will improve infrastructure and facilities and beautify the community.

Measure LC

On November 3, 2020, the voters of the City of Lancaster approved by the required majority vote, the City of Lancaster Transactions and Use Tax Ordinance. The collection of the ³/₄ cent Transaction and Use Tax began on April 1, 2021 and is being administered by California State Department of Tax and Fee Administration. The Tax is expected to generate approximately \$13.7M in general fund revenue in fiscal yeat 2021/22.

After thorough review and analysis of the fiscal year 2021/22 budget proposal staff is prepared to present the year 1 plan for the use of Measure LC funds. The Measure LC committee, through recent discussion identified that the priority for the use of the year one Measure LC funds shall be as follows:

- 1. Life Safety
- 2. Public Safety
- 3. Quality of Life

Staff recommends to add an additional priority entitled "Sound Fiscal Foundation/Support." As staff identified the number of specific uses of the funds all of these four priorities were taken into consideration. On June 2, 2021 the Measure LC committee approved the follow list of expenditures that can be added as a result of receiving Measure LC funds:

California Choice Energy Authority Budget

The California Choice Energy Authority is a Joint Powers Authority (JPA) comprised of member municipalities. Formed in 2012, the CCEA provides its members economies of scale to support the activities of each Community Choice Aggregate. CCEA initiatives remain in providing long-term sustainable energy and cost containment for member Community Choice Aggregates.

The CCEA Proposed FY 2021-2022 Budget totals \$1.6 million. The CCEA Proposed Budget projects an ending reserve totaling \$0.5 million by the end of FY 2021-2022.

The City's Proposed Fiscal Year 2021-2022 Budget and Five-Year Capital Improvement Plan and CCEA's Proposed Fiscal Year 2021-2022 Budget will be presented to the City Council and CCEA Board for final adoption on June 22, 2021.
