This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 83315). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

Project Description: The proposed project consists of the subdivision of approximately 26 acres into 103 single family residential lots. The lots would range in size from 7,002 square feet to 12,095 square feet. Access to the subdivision would be provided from 32nd Street East and Nugent Street. The streets within the subdivision would be public.

Location: The project site is located on the southeast corner of 30th Street East and Nugent Street (APN: 3150-028-005).

Mitigation Measures: Mitigation measures have been identified for Air Quality, Biological Resources, Cultural Resources, Geology and Soils, Hazards/Hazardous Materials, Noise, and Transportation .
