This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 61314). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

**Project Description:** The proposed project consists of a subdivision of approximately 30 acres into 84 single-family lots. The lots range in size from 10,010 square feet to 14,146 square feet. Access into the subdivision would be provided from Avenue K and Avenue K-4. All of the streets within the development would be private. A 6' block wall would be provided around the subdivision with a 4' landscape maintenance district along Avenue K.

**Location:** The project site is located on the southeast corner of Avenue K and 26<sup>th</sup> Street East in the City of Lancaster (Assessor Parcel Number [APN] 3170-007-056).

Mitigation Measures: Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, hazards/hazardous materials, and noise.
