This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 66680). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

**Project Description:** The applicant proposes to subdivide approximately 72 acres into 219 lots: 215 single family residential lots and 4 lots for drainage basins in the R-7,000 (single family residential, minimum lot size 7,000 square feet), R-10,000 (single family residential, minimum lot size 10,000 square feet), and R-15,000 (single family residential, minimum lot size 15,000 square feet) zones. Lots within the subdivision would range in size from 7,008 square feet to 17,239 square feet. Access to the subdivision would be from Avenue K-8 and 55<sup>th</sup> Street West. The parcels are currently undeveloped.

**Location:** The project site is located on approximately 72 acres generally bound by 52<sup>nd</sup> Street West, 57<sup>th</sup> Street West, Avenue K-8, and Avenue L in the City of Lancaster, California. Specifically, the proposed project is located on Assessor Parcel Numbers (APNs) 3204-006-025, -026, -027, -031, -032, -033, -067, -071, -075, -081, -085, -086, and -088.

**Mitigation Measures:** Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, hazards/hazardous materials, and noise.
