TITLE: TENTATIVE TRACT MAP (TTM) NO. 83573

This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM 83573). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

Project Description: The applicant (Rodeo Credit Enterprises, LLC) proposes to subdivide two vacant parcels, approximately 18.5 acres, into 67 single-family lots and one lot for a common area (68 lots total), which is planned to include a gym, pool, spa, outdoor park area, and dog run. The single family lots range in size from 7,432 square feet to 12,051 square feet. The common area lot is 14,518 square feet. Access into the subdivision would be provided from 42nd Street West.

Location: The project is located on approximately 18.5 acres at the northwest corner of 40th Street West and Avenue K in the City of Lancaster, California. Specifically, the proposed project is located on Assessor Parcel Numbers 3153-025-019 and 3153-025-043. These parcels are undeveloped and zoned R-7,000.

Mitigation Measures: Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, hazards and hazardous materials, and noise.
