A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, AMENDING THE ESTABLISHED CITYWIDE FEE SCHEDULE BY ESTABLISHING FEES RELATED TO THE CITY'S STUDIO 606 FACILITY

WHEREAS, Studio 606 is a newly established community space designed to support and promote various forms of artistic and creative expressions through music, visual art, and video/film production; and

WHEREAS, the City desires to ensure the sustainability of Studio 606; and

WHEREAS, the City desires to recover costs to contribute to the maintenance, utilities, staffing and upkeep of Studio 606; and

WHEREAS, the City seeks to establish Studio 606 Facility Use fees.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LANCASTER AS FOLLOWS:

Section 1. Fees for Studio 606 are hereby established in the amounts set forth in Attachment A.

Section 2. The effective date of this Resolution shall be February 14, 2024.

Section 3. Any Resolutions in conflict with provisions stated herein shall be considered superseded by the provisions contained with this Resolution.
