Project Description: This project will include removing and replacing existing curb ramps, curb and gutter, cross gutters, spandrels, and sidewalk. The project may also include some root pruning, tree removals and minor irrigation system modifications, at various locations within the City of Lancaster. All work will be completed within existing right-of-way. Depth of excavations is expected to be less than 2 feet below existing grade and there will be no modifications to existing utilities other than adjustment of manhole cover and valve covers to final grade.
