TITLE: TENTATIVE TRACT MAP NO. 84283 (TTM 23-011)

This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 84283 [TTM 23-011]). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

Project Description: The applicant proposes to subdivide approximately 20 acres into 56 single family residential lots in the R-10,000 (single family residential, minimum lot size 10,000 square feet) zone. Lots within the subdivision would range in size from 10,001 square feet to 17,994 square feet. Access to the subdivision would be from Avenue L-4 and all streets within the subdivision would be public. A block wall would be located along 70th Street West and Avenue L with a meandering sidewalk and landscaping.

Location: The project site is located on approximately 20 acres on the southeast corner of Avenue L and 70th Street West in the City of Lancaster, California. Specifically, the proposed project is located on Assessor Parcel Number (APN) 3204-004-024.

Mitigation Measures: Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, noise, and traffic/transportation.
