Project Title: PWCP 23-002 – Avenue K Grade Crossing - STPLR-7500 (276)

Project Location - General: City of Lancaster, County of Los Angeles, State of California

Project Location – Specific: Located at intersection of Avenue K and the Railroads near Sierra Highway

Project Description: The City of Lancaster in cooperation with the California Department of Transportation (Caltrans), proposes to construct safety improvements to the at-grade crossing at the intersection of Avenue K and the Railroad facilities near Sierra Highway. Both the Union Pacific Railroad (UPRR) and the Southern California Regional Rail Authority (SCRRA) own facilities within the project area. The project is federally funded through the Federal Highway Administration (FHWA) Section 130 program and is a combination effort of improvements between the City of Lancaster and the Railroads (UPRR & SCRRA). The project includes installation of advance preemption, relocation of Standard 9 flashing light signal assembly with automatic gate arm, relocation of existing catch basins, installation of pre-signal, concrete panel surfacing, new flashing light signal pairs directed south at Sierra Highway, at-grade crossing advance warning signage, installation of vehicle video/loops detection, pavement reconstruction, signal modifications; new signage and warning features; median reconstruction,; sidewalk and curb ramp improvements; revised road striping and signage; new street lighting; potential adjustment and/or undergrounding of utilities; pedestrian emergency egress swing gates; and rail-road access control fencing (replace existing wood fence with approximately four feet tall metal fence; installing approximately 500 feet of fencing [250 feet on northeast and 250 feet on southeast quadrants of the crossing]. No ROW acquisition is required. All work will be done within the existing right-of-way.
