

RESOLUTION NO. 08-34

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, APRIL 8, 2008, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW REGARDING ADVISORY MEASURE "A" AND ADVISORY MEASURE "B"

WHEREAS, a General Municipal Election was held and conducted in the City of Lancaster, California on Tuesday, April 8, 2008, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law, voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the City Clerk has canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A"; and

WHEREAS, the whole number of ballots cast in the precincts including vote-by-mail ballots and provisional ballots was 10,988; the total percentage of voter turnout was 20.5%.

WHEREAS, the results of the vote on Measure A were 6173 - YES and 2293- NO; and

WHEREAS, the results of the vote on Measure B were 2867 - YES and 2722 - NO; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LANCASTER, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the City Council, pursuant to its right and authority, does hereby accept the results of the votes cast in regards to the following "advisory" questions:

ADVISORY VOTE ONLY

A) Should the City of Lancaster adopt an ordinance providing for the consolidation of the Lancaster General Municipal Election with the countywide school district election to be held in November of odd numbered years commencing <b>November 2009</b> .	YES

ADVISORY VOTE ONLY

B) Should the City of Lancaster adopt an ordinance providing for the consolidation of the Lancaster General Municipal Election with the countywide school district election to be held in November of odd numbered years commencing <b>November 2011.</b>	YES

SECTION 2. The “Advisory Measure” shall pass (*as advisory only*), if at least a majority of the voters voting, vote yes. If both “Advisory” Measures pass, then the measure with the greatest number of “yes” votes shall prevail.
